#### Overview of the role

The general finance office tasks are split and rotated between the 2 Finance Assistants and Finance Apprentice and adhere to the University's segregation of duty requirement.

## Responsibilities

- To preparation of orders using Oracle Financials and departmental credit card –
  This will include raising purchase requisitions and generating purchase orders.
  Average number of orders per day is approx. 20
- To set up new suppliers and amend existing ones on Oracle financials through central finance
- To match delivery notes using Oracle Financials to receipt delivered goods against purchase orders. Advise and investigate any anomalies.
- To deal with any queries from suppliers about purchase orders raise
- To investigate and resolve any variations in the invoices compared to the purchase orders and where necessary liaise with the supplier to obtain a credit note.
- To review and update the open purchase order report monthly and clear any orders that are no longer required. To resolve any queries and distribute the report to the Finance Team Leader, any orders that remain outstanding for more than a month that cannot be cancelled.
- Process invoices in the Oracle Financial system and deal with anomalies, escalating complex queries to the Finance Team Leader.
- To be responsible and coordinate all the departmental travel requirements.
  Including raising POs and matching to the on line travel portal or email requests
  and confirming to the University's preferred supplier for travel, ensuring that the
  correct authorisations are attached for meeting both research sponsors and
  departmental cost centres required regulations. Dealing with any queries that
  may arise for travel booked through the supplier
- To check for correctness all invoices input by another finance assistant where a purchase order has not been raised
- To check the credit card statement has correct receipts and charging authority's code as requested and input into Oracle.
- To check a number of the reimbursement claims received in the finance office and ensure that the correct receipts are attached to each claim. To check that the expenses being claimed for, are bona fide expenses as described in the University's expenses and benefits manual and research project sponsors regulations. Code the claims to the relevant cost centre or research projects and cost categories.
- To be responsible for the payment of student bursary payments, setting up recurring payments and creating payment requests for those where a recurring payment cannot be set up
- To prepare and enter journals into Oracle financials when required.
- To maintain databases and update records, checking figures for errors and omissions
- To maintain supplies in the stationery cupboard and order stationery to ensure the department has adequate stocks

- To issue the software engineering part time course student invoices during times of absence of the other finance assistant or during busy periods.
- To complete forms for any banking of cash or cheques and liaise with the Finance Team Leader for delivery of these to Central Finance
- To deal with any petty cash requests from individuals ensuring that procedure for paying out petty cash is adhered to.
- To reconcile the Petty cash monthly and preparing the forms for reimbursement to be sent to Central Finance. Input into Oracle the petty cash reconciliation journal for the cost distribution
- To answer straight forward queries on Finance issues, providing basic advice on financial policies and procedures as appropriate, and referring to the Finance Team Leader of any complex cases.
- Any other duties that may be required from time to time either by the Finance Team Leader or Finance Manager
- To provide cover for reception as required

## **Pre-employment screening**

All offers of employment are made subject to standard pre-employment screening, as applicable to the post.

If you are offered the post, you will be asked to provide proof of your right-to-work, your identity, and we will contact the referees you have nominated. You will also be asked to complete a health declaration (so that you can tell us about any health conditions or disabilities so that we can discuss appropriate adjustments with you), and a declaration of any unspent criminal convictions.

#### **Department of Computer Science**

The Department of Computer Science was established in 1957, making it one of the longest-established Computer Science departments in the country. It is one of the UK's leading Computer Science Departments (ranked first in a number of international rankings). The UK Research Excellence Framework (REF) in December 2014 resulted in 74 members of the Department having 53% of their research activity ranked in the top category of 4\* (world-leading). Overall, we received an average of 3.34 across the Department (3\* being internationally excellent). A significant majority of the Department are active in externally sponsored research, with both government and industrial funding. At present, there are 69 members of academic staff and almost 100 research staff.

The Department has close links with government, industry, and other departments within the University. Among the latter are Mathematics, Engineering, Physics, Statistics and a number of life sciences departments. The Department is housed across multiple sites within the University's South Parks Road Science Area, facilitating strong collaborative links with research groups and institutes in closely allied areas (including the Oxford Internet Institute and the Oxford e-Research Centre). This is an essentially inter-disciplinary activity which is at present attracting major funding from a number of sources. At present, the Department holds over £50m in external research contracts.

Research in the Department is currently managed in ten themes:

 Algorithms & Complexity Theory focusses on determining the inherent difficulty of computational problems, classifying problems according to this inherent difficulty, and

- designing and analysing algorithms that use computational resources as efficiently as possible;
- Artificial Intelligence & Machine Learning focuses on theoretical foundations, multiagent systems, deep learning and computational linguistics;
- Automated Verification investigates theory and practice of formal verification and correct-by-construction synthesis for software and hardware systems;
- Computational Biology & Health Informatics is concerned with computational approaches for biomedical research and healthcare innovation;
- Cyber-Physical Systems is focusing on intelligent and autonomous sensor systems
  with applications in positioning, healthcare, environmental monitoring and smart
  cities;
- Foundations, Structures and Quantum embraces interdisciplinary research, and has a particular interest in structural foundations of quantum computation;
- *Human-Centred Computing* covers human-computer interaction, social computing and world-wide web:
- Information Systems covers databases, knowledge representation and reasoning;
- *Programming Languages* covers functional programming, program analysis, and programming language foundations;
- Security specialises in cybersecurity, protocol analysis, systems security, trusted computing, human-centred security, and networking.

#### The Mathematical, Physical, and Life Sciences Division (MPLS)

The Mathematical, Physical, and Life Sciences (MPLS) Division is one of the four academic divisions of the University. Oxford is widely recognised as one of the world's leading science universities. The disciplines within the MPLS Division regularly appear at the highest levels in world rankings. In the results of the six-yearly UK-wide assessment of university research, REF2014, the MPLS division received the highest overall grade point average (GPA) and the highest GPA for outputs. We received the highest proportion of 4\* outputs, and the highest proportion of 4\* activity overall. More than 50 per cent of MPLS activity was assessed as world leading.

The MPLS Division's 10 departments and 3 interdisciplinary units span the full spectrum of the mathematical, computational, physical, engineering and life sciences, and undertake both fundamental research and cutting-edge applied work. Our research addresses major societal and technological challenges and is increasingly focused on key interdisciplinary issues. We collaborate closely with colleagues in Oxford across the medical sciences, social sciences and humanities, and with other universities, research organisations and industrial partners across the globe in pursuit of innovative research geared to address critical and fundamental scientific questions.

The University operates an Employer Justified Retirement Age (EJRA) for all academic posts and some academic-related posts. The University has adopted an EJRA of 30 September before the 69<sup>th</sup> birthday for all academic and academic-related staff in posts at **grade 8 and above**.
