The role

To reinforce the Translational Ubiquitomics-Cancer Immunology research team within the CAMS Oxford Institute (COI) institute Nuffield Department of Medicine (NDM), we seek a highly motivated individual for the role of a Research Assistant. Our research group is focused on studying the Ubiquitin-Proteasome System, a critical regulator of the fate of most cellular proteins. We are interested in discovering aberrant function of the UPS in the context of cancer immunology, and how this can be exploited for the development of novel therapeutics.

The main responsibility of this post is to support the laboratory in the characterization of cancer immunomodulatory target genes by different proteomic, biochemical, and immunological techniques. In addition, you will support industry-related activities, including small molecule inhibitor characterisation by studying their activity and selectivity profile, in vitro and in living cells, using activity-based probes and a number of proteomic approaches. In addition, the effects (viability, migration, metabolism, immunogenicity...) of these genes and drugs in cancer cell models will be evaluated in combination with genetic impairment of the selected target gene using knockdown/CRISPR knockout experiments.

Responsibilities

You will:

- Perform experiments examining deubiquitylase (DUB) activity profiles using molecular active site probes and small molecule inhibitors.
- Perform research work with human and mammalian cell lines (tissue culture), including the generation and maintenance of knockout and knockdown cell lines using CRISPR/siRNA.
- Prepare mass spectrometry (MS) samples from a variety of biological sources (i.e. patient tissue biopsies, cell cultures, blood, peripheral blood mononuclear cells (PBMCs), etc).
- Perform functional validation assays including FACS, ELISA, and Incucyte..
- Assist with complex proteomics and mass spectrometry data analysis.
- Be responsible with others for the biological safety of the laboratory.
- Perform laboratory tests in order to produce reliable and precise data to support scientific investigations.
- Keep detailed record of all activities and to consolidate data from various projects within the group, interpret the results and to present them to other team members, including external collaborators.
- Contribute to general lab management (ordering and organisation of stocks)

Education and Training

- Attend appropriate scientific seminars, training opportunities and meetings within the research team, in the Centre and University.
- Participate in the education and training of other staff as necessary and appropriate.

General Responsibilities

- Act at all times in the interests of the Institute to ensure good laboratory practice.
- Be accountable for personal professional conduct within the project.
- Undertake such other duties as may be required from time to time that are commensurate with the grade and responsibilities of this post.
- Ensure that work in the laboratory is conducted safely and, in particular, that work is undertaken using appropriate safety procedures and in the dedicated areas.

Selection criteria

Essential

- Degree in biology, immunology, biochemistry, chemistry, biotechnology or similar.
- Familiarity with biochemistry techniques (e.g. Immunoblotting, immunoprecipitation, pull-down, in vitro enzymatic activity assays).
- Familiarity with flow cytometry analysis, ELISA, and immune cell purification and culture.
- Experience in handling cells, tissue culture and gene knockout/knockdown.
- Exposure to Chemical Biology, handling of small molecule inhibitors, peptides.
- Basic knowledge of mass spectrometry techniques including sample preparation.
- Basic knowledge in protein chemistry, expression, separation/purification methods.
- A responsible nature with a methodical and careful approach to working in the laboratory independently
- The ability to communicate results clearly and effectively and to discuss scientific ideas both within the work environment.

Desirable

- Experience in sample preparation for mass spectrometric analysis (Proteomics and/or Metabolomics).
- Expertise in 1D (2D) electrophoresis, and FPLC & HPLC.
- Experience in MS data analysis and statistics (i.e. MaxQuant, Perseus, Prism).
- Basic knowledge of operating an HPLC and mass spectrometer (LC-MS).

About the Nuffield Department of Medicine (NDM)

The Nuffield Department of Medicine aims to improve healthcare internationally through its research and teaching. Over the last fifty years, it has pioneered the use of genetics, structural and cellular biology to understand susceptibility to human disease; at the same time, it remains a department of clinical medicine with a clinical interface at the core of its success. The NDM is the largest department in the University of Oxford and the largest department of medicine in Europe by research income.

The department is organised around a series of strong and identifiably unique institutes, centres and units; but its aim is to be as non-hierarchical and closely-knit as possible, to encourage the very best interactions and the exchange of ideas between its staff. It supports teaching to encourage the very best students to join academic research. It maintains a £800m portfolio of externally funded research from over 140 different sponsors/funders, and has an annual turnover approaching £200m. The department's activity is run directly through the University, but also through a series of subsidiary companies and other legal vehicles, tailored to the activity and the countries within which it operates. Across these vehicles and partnerships, the department has over 3,000 staff and students working solely on, or supporting, its research and teaching; and 1,000 of these staff are based in Oxford. The NDM holds collaborative grants with ~40 other departments or centres in the University of Oxford.

The NDM is recognised for its diverse impacts in the field of healthcare. These range from the discovery of the mechanism of hypoxic gene regulation (Sir Peter Ratcliffe, Nobel Prize 2019) to the worldwide introduction of artemisinin and combination therapy for malaria (Sir Nick White and others). The underlying strength of the department, and its ability to bring together disciplines, has been evident through its contributions to the pandemic response, including: ISARIC and its overseas activity, IDDO and TGHN, the work of the Africa-Asia Programmes, the Oxford-AZ vaccine, elucidating the structural biology of variants and neutralising antibodies, the Office of National Statistics study, the UK Serology Surveillance platform, the standard testing of commercial assays for the Government, Mobile Apps, RECOVERY trial leading to the worldwide use of dexamethasone, the NHS cohort studies, the COMBAT study. This activity has certainly saved more than 2m lives during the pandemic.

The major strategic plans of the NDM are built around, (1) establishing a step-change in to clinical pathology and the study of human disease in all clinical specialities; (2) accelerating the discovery of new medicines; and (3) addressing the burden of worldwide infectious disease, including emerging threats. The GSK-Oxford Molecular and Computational Medicine Institute (MCMI) is aligned with this vision and will be primarily based in its Wellcome Centre for Human Genetics and Big Data Institute with strong links to other departments and its overseas activity.

The NDM has a strong commitment to careers and equality of opportunity and treatment. The Department holds an Athena SWAN Silver award in recognition of the commitment made to promote gender equality through our organisational and cultural practices and our efforts to improve the working environment for both men and women.
