The role

We're offering an interesting and varied Data Architecture role in the IT Services department of the University of Oxford.

As a Data Architect, you will work on a broad range of IT and business change projects – modelling and describing data to enable more effective, efficient operations, and inform decision-making.

You will collaborate with creative and dedicated colleagues to improve data management, access, usage and governance. You will bring both an eye for detail and an enterprise-wide perspective, ensuring that the projects you work on are aligned with the University's strategic data-related objectives.

You will communicate with colleagues from many seniority levels and backgrounds, bring clarity to complex problems and steer stakeholders towards the most effective and strategic outcomes.

You will provide technical advice and mentoring on specific Data Architecture tasks to other members of the team.



Selection criteria

Essential selection criteria

1. Experience in capturing, analysing, modelling and documenting data across a complex business application portfolio, producing:
 - Conceptual, logical, and physical data models
 - Data definitions
2. Experience of designing specifications for data integrations, migrations and business intelligence.
3. Experience of supporting Information Compliance and Security.
4. Experience of working with business, data and IT colleagues who have differing viewpoints, levels of technical understanding and seniority, explaining and visualising detailed data information to them.
5. Demonstrable creative and analytical problem-solving skills; able to balance pragmatic and idealistic thinking.
6. Evidence of being a completer-finisher who works with accuracy and precision.
7. Supportive, collaborative and inclusive work-style; able to challenge ideas in a professional and constructive manner in order to achieve a better outcome for the broader business/IT community.
8. Experience of prioritising and estimating workloads and responding to colleagues dependent on your outputs.
9. Experience of advising and mentoring other team members on specific Data Architecture tasks.

Desirable selection criteria

1. Experience of using Erwin Casewise-Evolve, or other enterprise modelling toolset.
2. Knowledge of the data structures and business activities of one or more university administrative functions (e.g. student records, research management, finance, human resources, alumni, identity etc.)

The University operates an Employer Justified Retirement Age (EJRA) for very senior research posts at **grade RSIV/D35 and clinical equivalents E62 and E82**, which with effect from 1 October 2023 will be 30 September before the 70th birthday. There is no normal or fixed age at which staff in posts at other grades have to retire. Staff at these grades may elect to retire in accordance with the rules of the applicable pension scheme, as may be amended from time to time.
