#### The role

This role sits within the CMS and Web Platform Team who are responsible for the development and support of the University's Drupal web publishing platform, Oxford Mosaic, as well as several React/Node.js applications hosted on AWS. The Mosaic platform, which currently supports upwards of 800 sites, is used by clients University-wide to build websites in support of public engagement, outreach, administration, and research dissemination. The React/Node.js applications provide specific systems to the University's museums, humanities and administrative units. This role is one within a dynamic and friendly team of 5 developers, 2 functional analysts and a Platforms Manager working on delivery of major initiatives and ongoing services for system development and maintenance.

This role is for an experienced developer who is able to use their experience and creativity to make a positive contribution within the team. As a highly skilled Web developer able to collaborate effectively with a wide variety of people across disciplines, the post holder will be responsible for the development of the platforms' projects and services as well as delivering key engineering improvements.

The post holder should have a background in the full lifecycle of web and application development and ideally will also have experience with source control, as well as being versed in continuous integration workflows and methodology.

As a senior developer, the post-holder will be expected to develop a thorough knowledge of the web platforms, be a source of technical expertise to the team, and take a pivotal role in the technical design, coding and testing of













new features, enhancements and fixes. You will be committed to the working practices, procedures and standards that underpin high quality development and recognise the importance of testing and quality control.

You will be capable of working both independently and as a technical lead within development teams. You will be articulate, possess excellent interpersonal skills and be able to work closely with customers where required.

The post holder will have excellent problem-solving skills, be self-motivated and have a proven track record in meeting deadlines within a multi-project environment. You will be flexible, adaptable to changes and able to provide innovative solutions.

# Responsibilities

- Take a lead role in the technical design, coding, testing and documentation of code changes required to build systems, implement changes and resolve platform issues, following compliance and best practice standards for security, privacy and accessibility
- Liaise with the Business Analysts, Designer and users through all stages of design, development and testing to ensure that developments meet the users' requirements
- Manage own workload and work effectively with others to deliver new developments, support and enhancements to required timescales, including making emergency fixes and ensuring continuity of service
- Manage operational activities of development work, attending meetings and providing planning estimates, technical priorities and updates on progress to the delivery or service manager
- Work with other developers to ensure that development undertaken fits with platform code patterns and release schedules
- Contribute to team planning sessions undertaking solution design for the strategic development of the platforms
- Review and make suggestions for improving development processes and procedures, helping the team work together in the most efficient manner and share lessons
- Communicate directly with users on technical matters and present options for technical solutions using software demonstrations, walkthroughs and prototypes where appropriate
- Provide product reviews and technical advice to Trainers, Functional Analysts and other colleagues as required
- Work with 2<sup>nd</sup> line Functional Analysts to triage and diagnose platform issues
- Proactively extend and develop expertise and technical skills through self-development
- Undertake other duties commensurate with the role and the grade as may be required

- Education to degree level in a computing or IT related subject or able to offer the equivalent in terms of professional experience.
- The ability to meet tight deadlines with an adaptable and flexible attitude towards the demands of their iob.
- A creative approach to problem-solving.
- Careful attention to detail and an ability to demonstrate an understanding of the need for programming and documentation standards in development work.
- The ability to work within, and contribute to, a team environment and build and maintain effective working relationships with customers, users and colleagues within the wider team.

### Desirable selection criteria

- Some experience of working in or with the higher education institutions.
- Experience in an Agile Development methodology such as Scrum or DSDM.

- Knowledge of continuous integration methodologies and automated deployment.
- Experience of developing to the WCAG 2 accessibility standards

- Expertise in supporting Drupal-based CMS systems, including working with modules and themes
- Proficiency with the tools, languages, and frameworks for Drupal based Website development:
  PHP/MySQL, JavaScript, HTML, and CSS and Responsive Design

- Expertise in developing on the AWS Cloud
