## The role

The Network Support and Development team provides some of the University's key networks and networking services. Our network engineers develop and maintain, among other things, the campus backbone, data centre networking, and central wireless infrastructure. You will have the opportunity to take ideas all the way from design through to deployment. Our services employ a wide range of technologies which makes for an interesting and challenging environment. You will work closely with other experts across the department and the wider University.



### Responsibilities

- 1. Providing significant input into the management, development and support of University Network Services.
- 2. Provision of specialist support and advice to system users.
- 3. Specialist network hardware and software configuration and problem resolution.
- 4. Installation, maintenance, and administration of network switches and routers. This will involve visiting remote sites with the appropriate equipment and ensuring that this sensitive equipment is handled correctly.
- 5. Development of new, and existing, network services to provide new/additional functionality, security and performance.
- 6. Responding to complex technical queries from a wide range of University, and external, users.
- 7. Setting up operational procedures to handle both operational and emergency situations.
- 8. Recording, analysing and publishing performance data relating to services provided.
- 9. Setting and maintaining high professional standards, displaying ethical and professional behaviour in all situations.
- 10. Informing the University and its members of key information and developments by lectures, online documentation and individual user consultation and advice.
- 11. Participating in the induction and mentoring of junior team members.
- 12. Taking advantage of appropriate training opportunities as these arise, in order to keep up to date with relevant skills and developments.
- 13. Participating in a regular Staff Development Review.
- 14. Carrying out other appropriate duties from time to time as required.

## Selection criteria

### Essential selection criteria

- 1. University degree or equivalent, or relevant industry experience.
- 2. Demonstrable experience and expertise in enterprise systems and network management.
- 3. Considerable experience of a major network vendor's hardware and software e.g. HPE Comware, Cisco IOS.
- 4. Detailed knowledge of networking hardware, software and protocols especially OSPF, STP and BGP.
- 5. Experience of, and commitment to, delivering secure, reliable and highly available networks.
- 6. Clear evidence of good interpersonal skills, ability to work with staff at all levels in the University, selfmotivation and ability to work on own initiative.

### Desirable selection criteria

- 1. The above experience in an academic environment.
- 2. Cisco CCNP or equivalent qualification from another networking manufacturer.
- 3. Knowledge of and (ideally) experience of IPv6.
- 4. Experience of delivering real-time voice and video over wired and wireless networks.
- 5. Experience of wireless networking.
- 6. Experience of working in enterprise class communication rooms and data centres.
- 7. Experience of automated provisioning and management of networking devices at scale.
- 8. The skills and experience to become an effective member of the team as quickly as possible.
- 9. Some knowledge of Unix systems day-to-day administration.
- 10. Some knowledge of Perl/Python or other scripting language.
- 11. Ability to follow established organisational policies and procedures.
- 12. Enthusiasm and interest in providing services and support to users.
- 13. Experience of mentoring and/or managing staff.
