The role

This role is part of the Connected Communications Service (CCS) which is a shared service communications team that sits in the Social Sciences Division and the only team of its kind at the University of Oxford. Essentially, we act as an internal communications consultancy for the departments in the Social Sciences Division who have signed up to our services.

Departments can buy into the CCS team on a retained model, providing consistent and predictable delivery of their ongoing communications needs. We currently work like this for four departments and the Social Sciences Division, covering a mixture of external, internal, alumni and digital communications, and event assistance. In addition, we can engage on an ad-hoc advisory basis – expanding the retained model for special projects or providing strategic communications consultation.

Working as part of a special project for the Oxford School of Global and Area Studies (OSGA), the post holder will be a digital communications specialist, with experience working with MOSAIC to drive widereaching improvements and a visual refresh across the OSGA website. They will understand how important digital communications is in higher education, its role in student recruitment, internal communications and how it can help the departments supported by the CCS achieve their strategic aims.



Responsibilities

- Write, edit and proofread a range of website content for the client's key audiences e.g. research impact pages, news stories, section summaries & introductions.
- Develop and update the department's website, including implementing best-practice navigation, ensuring it meets current UK accessibility regulations.
- Curate engaging photography, graphics, videos and other visual content to refresh the website's visual appearance within the existing CMS.
- Ensure that website content follows the house style and branding, supporting other team members and web editors to achieve this.
- Plan and organise photography sessions as required and within budget to support the improved visual appeal of the website.
- Implement appropriate methods for benchmarking and evaluating the website, analysing the results to inform value-add reporting to the client department.
- Lay the groundwork for an effective 'lift-and-shift' of existing website content to a new website to be developed in the future.
- Work collaboratively as part of a client-facing team and with members of the client department to deliver excellent results and ensure effective handover and sharing of responsibilities for ongoing success.
- Be an active member of the University's Communication Officers network and/or other relevant networks/groups in order to share information, promote best practice and ensure cross-University communications are coordinated.

Selection criteria Essential

- 1. Extensive communications experience in digital media, with up-to date knowledge and skills.
- 2. Ability to work independently in a busy environment, balancing multiple priorities effectively to meet deadlines.
- 3. Proven experience of editing, updating and maintaining websites in MOSAIC and knowledge of website accessibility regulations.
- 4. Proven experience in producing effective web content, including managing SEO, navigation and user journey.
- 5. Proficient in working with online team collaboration tools, particularly Teams, SharePoint and other Office 365 platforms.
- 6. Excellent copywriting, editing and proofreading skills and attention to detail, with a proven ability to communicate complex concepts to a non-specialist audience.

- 7. Proven experience producing strong visual content using Photoshop, Canva or similar.
- 8. Excellent interpersonal skills, including diplomacy and the ability to inspire the confidence of senior colleagues within a client relationship.
- 9. Excellent analytical skills, including experience benchmarking and reporting SEO and Google Analytics.

Desirable

- 1. Experienced in servicing clients and meeting customer needs within communications, digital consultancy, or web design.
- 2. Able to positively respond to changes of direction and client requirements once projects are already underway.

The Social Sciences Division

The University's academic departments and faculties are organised into four large groups known as Academic Divisions (Social Sciences, Mathematical, Physical and Life Sciences (MPLS), Medical Sciences, and Humanities). The divisions are responsible for academic strategy and operational planning, oversight of the teaching and research of their constituent departments and faculties, and for personnel and resource management. The social sciences at Oxford are distinctive for both their depth and breadth, with over 1,100 academic and research staff working across fifteen departments, faculties and schools. The Head of the Social Sciences Division is Professor Timothy Power.

The Division is a world-leading centre of research and education in the social sciences. The Times Higher Education (THE) University Rankings returned the University of Oxford to the number one spot in the world for Social Sciences in 2022. We have placed first in three of the last five years (2018, 2019 and 2022).

More than 800 researchers were returned to Main Panel C (Social Sciences) for REF 2021 across a diverse range of subject area 'units of assessment' – from geography and business to archaeology and law. Over 55% of the research submitted from the Division was judged to be world-leading (4*, the highest score available). More than two-thirds (69%) of the research's impact was also recognised as world-leading (4*). Research from across the Division was also submitted to subject areas across Panels A (Medicine, health and life sciences), B (Physical sciences, engineering and mathematics), and D (Arts and Humanities), highlighting the enormous breadth and diversity of research expertise across the Division.

Our academic and research staff and students are international thought leaders, generating new evidence, insights and policy tools with which to address some of the major global challenges facing humanity, such as sustainable resource management, poverty and forced migration, effective governance and justice. Particular research highlights in recent years have included COVID-19 and Climate Change. As well as active interdisciplinary links with researchers in other divisions at Oxford, we engage and collaborate extensively with other universities and a wide range of governmental and non-governmental

practitioner communities such as law, business, public health and welfare, international development and education around the world. The Division has an extensive portfolio of external funders, partners and supporters, with competitively-awarded external research income exceeding £50 million per year and philanthropic income over £25 million a year.

As part of our commitment to equality of opportunity, eleven of our departments have achieved Bronze awards under the Athena Swan Charter (a UK accreditation scheme recognising organisations' commitment to equality and diversity, particularly in gender). Our School of Geography and the Environment holds an Athena Swan Silver award. In February 2023, for the first time, the University as a whole was awarded an institutional Athena Swan Silver award, acknowledging the progress that has been made in addressing a number of gender gaps across the University over the last five years.

The Division delivers an exceptional range of high-quality educational programmes all underpinned by the innovative research being undertaken by our academics. The student body is made up of over 2,000 undergraduate students, nearly 3,000 students studying postgraduate taught programmes and 1,200 postgraduate research students. The programmes we offer are wide-ranging, often interdisciplinary and include professionally-oriented provision in areas such as business, law and education. The Division is home to several of Oxford's most widely recognised teaching programmes, such as Philosophy, Politics and Economics (PPE) at undergraduate level; and at the Masters level programmes such as the Bachelor in Civil Law (BCL), Environmental Change and Management, International Relations, and Social Data Science.
