About Oxford Population Health

Oxford Population Health (the Nuffield Department of Population Health) provides an excellent environment for multi-disciplinary research and teaching and for professional and support staff. This comprised research from Oxford Population Health and research from the Nuffield Department of Primary Care Health Sciences. We scored particularly well for having an environment that is conducive to producing research of world-leading quality and enabling outstanding impact, in terms of its vitality and sustainability.

In addition to its research activities, the Department is home to the <u>MSc in Global Health</u> <u>Science and Epidemiology</u>, the <u>MSc in Clinical Trials</u>, and a variety of short courses. Students also come to undertake research for <u>DPhil degrees</u>. Teaching is provided for undergraduates reading for Medicine and for public health doctors in specialist training.

The China Kadoorie Biobank Study

The China Kadoorie Biobank (CKB) Study (www.ckbiobank.org) is a uniquely rich and powerful global resource for investigating the environmental and genetic determinants of common chronic diseases. It is a long-term prospective cohort study of >512,000 men and women aged 30-79 years who were recruited during 2004-08 from ten geographically diverse urban and rural regions across China. The study aims to investigate the lifestyle, behavioural, environmental and genetic factors contributing to the aetiology of common chronic diseases, including heart disease, stroke, cancer and respiratory disease.

The study is conducted jointly by the NDPH in Oxford, and the Chinese Academy of Medical Sciences and Peking University in Beijing. The Oxford CKB team now has >40 staff, plus >15 DPhil students and academic visitors. Since February 2017, the CKB team has been based in the Big Data Institute, bringing opportunities for interaction and collaboration with world leaders in the analysis of complex multidimensional datasets.

The role

A full-time Data Wrangler is needed to join the existing China Kadoorie Biobank (CKB) Central Data Repository Group to support epidemiologists, geneticists, clinicians and statisticians in analysing data from the CKB. The role will include elements of Data Engineering, Data Curation, and Data Analysis. Duties will include integrating and managing vast amount of complex data, investigating and resolving data issues, answering questions about data sources, and much more.

The successful applicant will work closely with a multi-discipline team of software developers, systems testers, epidemiologists, statisticians, clinicians, and administrative staff to ensure smooth continuation and expansion of the study. The post holder will report directly to the CKB Data Group Lead.

Responsibilities

- Working closely with CKB's IT, epidemiology and research administration teams to assess, manipulate, clean and validate large datasets from a variety of sources. This includes data from assessment clinics, biological samples, remote devices, and health administrative datasets (including hospital, cancer and death records).
- Developing scripts to interrogate the databases, automate tasks and perform analyses.
- Producing reports on data handling and procedures, including recording changes to the databases and datasets in a well-structured manner.
- Provision of data analysis support to the CKB epidemiology and research administration team.
- Working closely with CKB team to support researchers worldwide to use the resource, including generating resources to help them understand the data.
- Designing, creating, and maintaining technical documentation including user requirement specifications, user manuals, training materials etc. within the CKB Data Group.

The list is not exhaustive and the role-holder is required to undertake such duties as may reasonably be requested within the scope of the post. All staff are required to act in a professional, cooperative and flexible manner, in line with the requirements of the post.

Selection criteria

Essential

- A good degree/higher degree or equivalent in a scientific or numerate subject, or able to demonstrate relevant experience.
- A talent for investigation and problem solving
- Experience of data management using large and complex relational databases.
- Experience of writing and optimizing complex SQL queries.
- Good knowledge of a scripting language (e.g., R, Python)
- Experience of extracting data from a large and complex database, and a good understanding of transferring and transforming data.
- Experience of writing and maintaining user requirements documentation.
- Excellent written and verbal communication skills.
- Demonstrable ability to pay attention to detail, including documentations.
- Ability to work independently and to show initiative.
- Proven ability to work within a team and under pressure to meet deadlines.

Desirable

- Understanding and/or experience of the use of health records for medical research.
- Understanding of the application of statistical methods to epidemiological studies.
- Experience in using statistical software packages (e.g. STATA, SAS, R or similar)
- An interest in medical/epidemiological research.
- Literate in Mandarin.

Pre-employment screening

Standard checks
