The role

The Blavatnik School of Government is looking for an experienced and highly skilled Monitoring, Evaluation and Learning (MEL) Manager to work at the heart of a new £30m six-year global research and policy effort.

The <u>What Works Hub on Global Education</u> (WWHGE) aims to dramatically improve learning outcomes for children in developing countries by generating new evidence on the "implementation science" of delivering what works at scale, with governments, and across contexts. The WWHGE will also work with policymakers and NGOs directly to ensure evidence is translated into improved learning outcomes in practice. It is an unusual collaboration of excellent and highly committed academics; low- and middleincome country governments; grassroots organisations who deliver education and advocate for change; and with strategic partners from the international education community, from UN agencies to the World Bank. We will also work very closely with our anchor funder: the UK's Foreign, Commonwealth and Development Office.



The MEL Manager will be responsible for the implementation of the results framework for the programme. They will lead the implementation of the monitoring plan and learning framework, facilitating technical (workstream) adaptation sessions for decision making, annual strategy testing and theory of change refresh sessions and ensuring that the MEL system generates measurable results and impact at programme level.

They will work with the MEL Advisers to ensure the MEL systems are designed to support learning, reporting and accountability. They will also work with the School project lead to ensure timely and high-quality reporting as set out in the programme MEL plan.

Responsibilities

- Ensuring effective implementation of MEL system including development and roll out of all tools and processes, in conjunction with MEL Adviser
- Facilitating learning and adaptation sessions with programme team
- Working with programme partners to gather, quality assure and analyse partnergenerated data. Designing and rolling out tools for partner reporting.
- Ensuring efficient data collation and analysis of programmatic reporting data
- Capacity development with partners to ensure reporting requirements can be met to FCDO standards and appropriate support is provided
- Packaging evidence to various stakeholders in the form of presentations, reports and written briefs, and contributing to quarterly and annual reporting
- Communicating results and evidence to internal external stakeholders as needed
- Maintenance and updating of the MEL workplan
- Ensuring adherence of all data collection processes with international best practice and FCDO ethical standards
- The MEL Manager will support partner tracking technical performance in relation to the ToCs and pillar-ToCs and on partner capacity support and development.

Selection criteria

- Experienced in designing and managing MEL strategies that enable a "fail-fast" approach to programme delivery and support adaptive management and learning.
- Experienced in designing MEL approaches to fill evidence gaps including targeted operational research and lessons learning
- Experienced in designing MEL plans that support scaling and adapting interventions in response to changes in external context.
- Demonstrated strong stakeholder management and communications skills including capacity development related to MEL approaches and communication to support data use
- Experienced in facilitating programmatic learning processes
- High quality written English

Desirable selection criteria

• Experience in managing MEL in a donor-funded project.
