The role

We are seeking an enthusiastic and motivated Postdoctoral Researcher to join an exciting Medical Research Council (MRC) funded project that focuses on increasing access to Cognitive Behavioural Therapy (CBT) for preadolescent children with obsessive compulsive disorder (OCD). We have worked with families and clinicians to develop a brief face-to-face/telephone therapist-supported, parent-led CBT intervention for preadolescent children with OCD. We now intend to conduct further work with families and clinicians to co-adapt a brief *online* version of this intervention and conduct a feasibility randomised controlled trial (RCT) and process evaluation of the brief online intervention in routine mental health services in the UK.

This project will involve: (1) working with key stakeholders (i.e., parents/children with OCD, clinicians, OCD charities) to co-adapt a brief online version of the intervention, (2) conducting a feasibility RCT to determine the feasibility of (i) the brief online intervention, and (ii) a definitive RCT comparing the clinical outcomes and cost-effectiveness of the brief online intervention to usual treatment in routine mental health services, and (3) to conduct a process evaluation to explore (a) the implementation and acceptability, (b) mechanisms of impact, and (c) contextual factors that affect delivery, engagement, and outcomes for the online intervention.

The postholder will co-lead all aspects of this project, working closely with the study investigators.



Responsibilities

- Co-lead and monitor project activities, including patient and public involvement activities, site and participant recruitment, quantitative and qualitative data collection, and data analysis.
- Work closely with study investigators and a range of collaborators to enable successful delivery of the project.
- Contribute to the design of project materials and protocols for ethical approval
- Manage own academic research and administrative activities. This involves project management, to coordinate multiple aspects of work to meet deadlines
- Adapt existing and develop new research methodologies and materials
- Prepare working theories and analyse qualitative and quantitative data from a variety of sources, reviewing and refining theories as appropriate
- Contribute ideas for new research projects
- Develop ideas for generating research income, and present detailed research proposals to senior researchers
- Collaborate in the preparation of research publications, and book chapters
- Present papers at conferences or public meetings
- Act as a source of information and advice to other members of the group on methodologies or procedures
- Represent the research group at external meetings/seminars
- Carry out collaborative projects with colleagues in partner institutions, and research groups

Selection criteria

Essential selection criteria

- Have or be close to the completion of a relevant PhD/DPhil, together with relevant experience
- Possess sufficient specialist knowledge of child mental health problems
- Experience of conducting Patient and Public Involvement (PPI) and/or co-design activities with lived experience individuals
- Experience of conducting and recruiting participants to randomised controlled trials (ideally in NHS settings)
- Experience of conducting and/or analysing qualitative interview data
- Experience of working with a range of key stakeholders (e.g., charities, external companies)
- Ability to manage own academic research and associated activities
- Previous experience of contributing to publications/presentations
- Ability to contribute ideas for new research projects and research income generation
- Excellent communication skills, including the ability to write for publication, present research proposals and results, and represent the research group at meetings
- Flexibility to work some irregular hours occasionally to fit with participant availability

Desirable selection criteria

- Experience of preparing NHS ethics application and data management plans
- Experience using data management software (e.g., REDCAP, Online Surveys)
- Experience conducting process evaluations
- Knowledge of, and/or experience delivering, mental health assessments (e.g., diagnostic assessments) and/or low-intensity interventions for child mental health problems

- Knowledge of, and/or experience applying, implementation science frameworks and/or PPI/co-production frameworks.
- Experience of independently managing a discrete area of a research project
- Experience of actively collaborating in the development of research articles for publication
