The role

The post holder will join the Oxford Space instrumentation group to support development of a clean room cryogenic high-vacuum testing facility for the Ariel space telescope mission, support the mechanical design and modelling of the Modular Infrared Molecules and Ices Sensor (MIRMIS) instrument and our contributions to multiple other planetary instruments. MIRMIS is a thermal infrared imaging instrument that Oxford is delivering for the ESA Comet Interceptor mission with additional channels contributed by VTT Finland. The post holder will work with the existing Oxford team to assist with development of mechanical and opto-mechanical design, produce manufacturing drawing, documentation and FEM analyses.

Responsibilities

- Support the mechanical and opto-mechanical design and development of the MIRMIS flight instrument
- Support the design, documentation and construction of the cryogenic, vacuum and clean room test facility for the Ariel mission
- Produce CAD models, manufacturing drawings and perform FEM analyses
- Support production of Product Assurance documentation for both instruments
- Support development of sub-systems for other space missions as they arise
- Ability to work as a team, attend project meetings
- Advice/involvement in developing conceptual ideas for further instruments/funding opportunities.
- Review system/sub-system requirements
- Provide independent oversight to other areas of the instrument development (i.e. through internal review)
- Develop technical documentation for review panels
- Participation in and giving presentations to reviews with funders (e.g. UK Space Agency) and external organisations (e.g. European Space Agency).

Pre-employment screening
