The role

The Research Assistant will provide research support to the Minerva Global Security Programme: Contested Cross-border Spaces, Illicit Flows, and Order in the Contemporary World, funded by the Minerva Research Initiative.

Led by Dr Annette Idler, the project seeks to illuminate the dynamic interactions of the political, economic, and social dimensions of global security: global order, transnational supply chains and local experiences of instability. Networked illicit flows of weapons, drugs, money, and trafficked people span contested cross-border spaces embedded in unstable regions. They can turn local security risks into a globally relevant phenomenon. We study how this mechanism works, and how it helps proliferate cross-border violence, strengthen armed actors, and shift the global balance of power. We expect that, together, these intersecting dynamics undermine global security, influencing order in the contemporary world. We work across different levels of analysis ranging from the local,



and national, to the transnational and global level, with a particular focus on Ukraine/Russia, South Asia, the Middle East, the Horn of Africa, the Andean Region, and the Golden Triangle.

It is envisaged that the Research Assistant will work approximately 10 hours per week focusing on collecting data on illicit flows and international criminal networks from public sources, including reports and news outlets.

Responsibilities

- Manage own research and administrative activities, within guidelines provided by senior colleagues;
- Contribute to wider project planning;
- Select, follow, and adapt specialist methodologies to confirm or refute theories, and identify suitable alternatives where information or research material is restricted;
- Contribute to the design of research materials and make arrangements for data gathering;
- Gather, analyse, and present qualitative and/or quantitative data from a variety of sources;
- Undertake comprehensive and systematic literature reviews and write up the results for publication in peer-reviewed journals or for presentation at conferences or public meetings;
- Contribute to research publications, book chapters and reviews.

Selection criteria

Essential selection criteria

- Hold a graduate degree in a relevant topic, together with some relevant experience;
- Possess sufficient specialist knowledge in the discipline to work within established research programmes;
- Ability to manage own research and administrative activities;
- Excellent communication skills, including the ability to write text that can be published;
- Experience of following and adapting methodologies for data collection and data analysis;
- Experience of collecting data on illicit flows from public sources, including reports and news outlets;
- Possess knowledge of mapping illicit flows, international criminal networks and the current political situation in at least one of these regions: the Golden Triangle, the Middle East and Gran Colombia.

Desirable selection criteria

- Experience of contributing to research publications;
- Experience of working in a research team and contributing ideas for new research projects;
- Elementary knowledge of R or Python.

Pre-employment screening Standard checks

If you are offered the post, the offer will be subject to standard pre-employment checks.
