## The role

We are looking to enhance our team of skilled technicians with a CNC Machinist who will work under the general direction of the Denys Wilkinson Building Workshop Supervisor to act as an integral member of the mechanical workshop within Oxford Physics. Primarily the duties are manufacturing components using standard machines and fitting them into assemblies and complete pieces of equipment required for research. Additional duties such as the installing, modifying and maintaining apparatus and equipment, which may take place on sites away from Oxford and abroad, are required.



## **Responsibilities**

Working from production or general arrangement drawings, sketching, written or verbal instructions, the specific duties include:

- The efficient and safe operation of the full range of standard mechanical workshop machines and other processes.
- Specialised duties within the training and experience of the post-holder, e.g. programming and operation of computer-aided machines, high precision instrument making, manufacture of pressure/vacuum vessels and equipment, welding.
- The fitting and assembly of components, sub-assemblies and complete equipment to appropriate precision and other standards.
- The installation, modification and repair of equipment required for teaching and research.
- Effectively interpret engineering drawings and calculations and quickly identify inconsistencies.
- Use own experience and judgement to solve complex problems relating to the manufacture or maintenance of equipment or apparatus.
- Assisting other workshop staff on tasks as required.
- Advising academic, research support and other staff or graduate students on the mechanical production aspects involved in their research or other activities.
- Any other related duties within the capabilities of the post-holder and appropriate to the role.

## **Selection criteria**

### **Essential**

- Experience of high technology research and development
- Experience of computer controlled machining
- Experience of manufacturing components using CNC and standard machines
- The post-holder is expected to have already acquired, and be able to demonstrate the necessary specialist skills and knowledge to allow him or her to perform the duties without supervision when working away from the workshop.

### **Desirable**

- A BTEC Higher National Certificate/Diploma in Mechanical or Production Engineering or an equivalent qualification is highly desirable
- Lower qualifications would be considered if offset by experience significantly greater than the minimum specified above
- Additional qualifications and/or experience would be advantageous
