The role

You will be part of the Paediatrics Finance & Grants team. The team comprises of 9 members of staff and you will be reporting directly to the Senior Finance Officer. You will deliver an excellent level of service to internal customers whilst ensuring financial policy and controls are adhered to. You will support the team and foster a “right first time” culture whilst looking to improve efficiency and striving for continuous improvement.



Responsibilities

- Processing all requisitions in line with university financial policy and supporting shoppers through the process. This involves obtaining quotes, tender exemptions, justifications, order acknowledgments and evidence of price. You will challenge shoppers, where necessary, to obtain value for money by using preferred suppliers. Review new supplier requests from end users and ensure they are justified. You will complete new supplier request documentation and monitor with colleagues in the central Finance Division that these have been processed.
- Be responsible for the preparation and entry of invoices for payment to ensure supplier payments are made in accordance with payment terms.
- Be responsible to ensure VAT has been correctly accounted for, to send VAT exemption declarations and ad-hoc VAT certificates to suppliers.
- Respond to straightforward internal and external enquiries, providing advice on financial procedures and policies and referring to the Senior Finance Officer and Finance Manager where necessary.
- Maintain good working relationships with suppliers and colleagues in the University's central Finance Division.
- Ensure you keep an up-to-date knowledge of the University's Finance regulations, policies, and procedures.
- Other routine and comparable computer and clerical duties as required.
- To undertake other responsibilities commensurate with the grade of the post as requested.

Essential
