Job description

Overview of the role

The postholder will be responsible for auditing, cleaning and improving the authorities data within the online catalogue of Manuscripts from the Islamicate World (fihrist.bodleian.ox.ac.uk). The Bodleian's history of collecting Persian manuscripts began in the year it opened, in 1602. Collections of John and Thomas Greaves in the 17th century, of Narcissus Marsh in the 18th, and of the brothers Gore and William Ouseley in the 19th century brought the total to more than 2,500 items. At present 1,500 are described in the online catalogue. Conversion of information in the printed catalogue by Hermann Ethé, published in 1889, to machine-readable form will enable greater access to the collection and will prepare the ground for further scholarly work to describe the manuscripts in greater detail. The work which needs to be done on the entries converted from the printed catalogue includes harmonizing and integrating name and place references, to enable cross-searching.

Improvements to the authorities data will aid the discoverability of these rich collections, allowing further integration of persons and places within the Bodleian's suite of Special Collections catalogues, while also creating new access points into the Bodleian's collections for external users and applications.

Responsibilities

- Work in an XML editing programme using TEI to contribute to further creation and development of collections content, such as manuscript descriptions, in consultation with Special Collections colleagues
- Analyse, structure and encode existing authorities data, including clustering, reconciliation and normalization, coordinating with Asian and Middle Eastern Collections and BDLSS colleagues
- Collaborate with colleagues in Asian and Middle Eastern Collections and BDLSS to ensure consistency and compatibility of data with the Fihrist catalogue
- Liaise as required with the Digital Bodleian team to review metadata for ingest as part of Persian collections digitization activities
- Any other tasks which may be required commensurate to the grade to improve and harmonise metadata for Persian manuscript collections

Other duties

- Participate in a regular Annual Review
- Undertake any necessary training identified
- Comply with health and safety regulations
- Comply with the policies and procedures set out in the Handbook for Academic Related Staff
- Any other duties that may be required from time to time commensurate with the grade of the job

- 2. Proven skills, or experience equivalent to those derived from holding a postgraduate degree, in some aspects of Persian manuscript studies

- 5. Very strong IT skills; comfortable working with digital data and with the ability to acquire new technical skills quickly
- 6. Expertise and interest in the field of Persian manuscripts, including electronic and paper reference works and research resources; experience of using catalogue descriptions.
- 7. Highly organised with excellent analytical and problem-solving skills
- 8. Excellent oral and written communication skills

Desirable selection criteria

- 1. Familiarity with the results of OCR'd text
- 2. Ability to work independently; co-operative attitude to working with colleagues
- 3. Experience of working with Person/Place name authorities (VIAF, ISNI)
- 4. Experience of working on a cataloguing project

Your referees will be asked to comment on your suitability for the post and to provide details of the dates of your employment; and of any disciplinary processes which are still considered 'live'. We will only take up references at offer stage.
