Oxford Population Health (the Nuffield Department of Population Health) provides an excellent environment for multi-disciplinary research and teaching and for professional and support staff. In addition to its research activities, the Department is home to the <u>MSc in Global Health</u> <u>Science and Epidemiology</u>, the <u>MSc in Clinical Trials</u>, and a variety of short courses. Students also come to undertake research for <u>DPhil degrees</u>. Teaching is provided for undergraduates reading for Medicine and for public health doctors in specialist training.

The China Kadoorie Biobank Study

The China Kadoorie Biobank (CKB) Study (www.ckbiobank.org) is a uniquely rich and powerful global resource for investigating the environmental and genetic determinants of common chronic diseases. It is a long-term prospective cohort study of >512,000 men and women aged 30-79 years who were recruited during 2004-08 from ten geographically diverse urban and rural regions across China. The study aims to investigate the lifestyle, behavioural, environmental and genetic factors contributing to the aetiology of common chronic diseases, including heart disease, stroke, cancer and respiratory disease.

The study is conducted jointly by the NDPH in Oxford, and the Chinese Academy of Medical Sciences and Peking University in Beijing. The Oxford CKB team now has >40 staff, plus >15 DPhil students and academic visitors and brings opportunities for interaction and collaboration with world leaders in the analysis of complex multidimensional datasets.

The role

A full-time Data Wrangler is needed to join the existing China Kadoorie Biobank (CKB) Data Group to support the day to day operations of the team. The role will include elements of Data Engineering, Data Curation, and Data Analysis. Duties will include integrating and managing vast amount of complex data, investigating and resolving data issues, answering questions about data sources and much more.

Candidates with limited experience but a desire to learn are encouraged to apply for the role.

The successful applicant will work closely with a multi-discipline team of software developers, systems testers, epidemiologists, statisticians, clinicians, and administrative staff to ensure smooth continuation and expansion of the study. The post holder will report directly to the CKB Data Group Lead. Please note that this is not a research role.

Responsibilities

• Undertaking regular processing, checking and refining of large amounts of new follow-up data from a variety of sources for inclusion in the CKB database.

- Designing, creating, and maintaining technical documentation including user requirement specifications, user manuals, etc. within the CKB Data Group.
- Documenting and maintaining records of all changes to the database and data queries by developing and maintaining an automated change control system.
- Undertaking preparation and delivery of specific dataset for use by internal and external researchers, and to deal with any queries raised.
- Responsible for providing advice to and answering questions and queries from data users.
- Assisting with regular release of study data and preparation and delivery of specific dataset for use by internal and external researchers
- Be an active participating member of the team, liasing with and contributing to the overall work of the data group within CKB.
- Carrying out other comparable and appropriate tasks as required.

The above list is not exhaustive and the role-holder is required to undertake such duties as may reasonably be requested within the scope of the post. All staff are required to act in a professional, cooperative and flexible manner, in line with the requirements of the post.

Selection criteria Essential

- A BSc in a scientific or numerate subject
- Evidence of technical competency, including the ability to use a progamming language.
- Excellent written and verbal communication skills, including the ability to write in clear and concise language, tailored for different audiences (e.g. technical engineers, beginner application users, and non-users).
- Good organisational and administration skills that show excellent attention to detail and a detailed approach to documentation.
- Strong reasoning and numeracy skills
- Ability to work on routine matters without supervision and to show initiative.
- Proven ability to work within a team and under pressure to meet deadlines.
- A positive attitude to learning and aquiring new skills.

Desirable

 Experience in using one or more statistical software packages (e.g. STATA, SAS, R or similar).

- The ability to extract data from a database, and a good understanding of transferring and transforming data.
- Experience writing and optimizing complex SQL queries.
- Literate in Mandarin.
- Experience with data quality assurance

Pre-employment screening

Standard checks
