Oxford Population Health (the Nuffield Department of Population Health) provides an excellent environment for multi-disciplinary research and teaching and for professional and support staff. We work together to answer some of the most important questions about the causes, prevention and treatment of disease.

This comprised research from Oxford Population Health and research from the Nuffield Department of Primary Care Health Sciences. We scored particularly well for having an environment that is conducive to producing research of world-leading quality and enabling outstanding impact, in terms of its vitality and sustainability.

In addition to its research activities, the Department is home to the [MSc in Global Health Science and Epidemiology](#), the [MSc in Clinical Trials](#), and a variety of short courses. Students also come to undertake research for [DPhil degrees](#). Teaching is provided for undergraduates reading for Medicine and for public health doctors in specialist training.

The role

This role will be within the Oxford Data Analyst team that helps support the UK Biobank study. The main responsibilities involve processing, analysing and managing health-related data from a wide range of sources into the UK Biobank resource. This includes developing and maintaining complex data pipelines, validating and documenting the results, and performing internal analyses to support operational and epidemiological research, as well as building and improving existing analytical tools. The successful candidate will also gain the opportunity to perform data processing and analytics on a state-of-the-art cloud-based platform, for which full training will be provided. This is a unique opportunity to become an expert in cloud-based analytics.

Other responsibilities of the role include: responding to queries from external researchers and internal collaborators concerning the UK Biobank resource, identifying issues with the resource's data and documentation and making improvements where necessary, providing data analysis support to the UK Biobank Scientific Team and the Scientific Study Development Group, and producing reports for internal analysis.

The post will suit someone with excellent data management/analytical skills, who can pay close attention to detail and who has good interpersonal skills.

The post will be based in the Nuffield Department of Population Health (NDPH) at the University of Oxford, although regular liaison with UK Biobank staff in Stockport will also be required. Opportunities will also be available for the successful candidate represent UK Biobank at national and international conferences, and provide training workshops to the global research community.

Responsibilities

Specific areas of responsibility will include:

- Working closely with UK Biobank's IT, epidemiology and research administration teams to develop and maintain pipelines to assess, manipulate, clean and validate large datasets from a variety of sources. This includes data from assessment clinics, web-based

questionnaires, remote devices and health administrative datasets (including hospital, GP, cancer and death records).

- Developing scripts and tools to interrogate the databases, automate tasks and perform analyses.
- Producing reports on data handling and procedures, including recording changes to the databases and datasets in a well-structured manner.
- Performing analyses to support operational research, and working with the UK Biobank epidemiology team on internal research projects.
- Working closely with UK Biobank's access team to support researchers worldwide to use the resource, including generating resources to help them understand the data.
- Development and delivery of teaching and training materials concerning the resource.

The above list is not exhaustive and the role-holder is required to undertake such duties as may reasonably be requested within the scope of the post. All staff are required to act in a professional, cooperative and flexible manner, in line with the requirements of the post.

Selection criteria

Essential

- An MSc in a scientific or numerate subject, or equivalent experience
- Substantial experience in data analysis
- Proficiency in writing R code for data import & manipulation, or proficiency in using a similar language (such as SAS, Stata or Python) for data import & manipulation and the ability to demonstrate that you can apply your knowledge to writing equivalent R code
- Working knowledge of SQL (e.g. ability to write queries involving joining tables, aggregate functions, updating and inserting into existing tables)
- Meticulous approach to data handling and documentation
- Experience using/processing large or complex datasets
- Excellent written and oral communication skills in English
- Ability to prioritise workload and to work under pressure on a variety of tasks concurrently

Desirable

- Understanding and/or experience of the use of health records for medical research
- Experience of programming and/or scripting in a linux environment
- Experience of working in a multidisciplinary team (e.g. a team involving clinicians, scientists, etc.) and/or in wider collaborative groups
- Experience of source control, particularly Git/GitLab
- Experience working with UK Biobank data

Pre-employment screening

Standard checks

If you are offered the post, the offer will be subject to standard pre-employment checks. You will be asked to provide: proof of your right-to-work in the UK; proof of your identity; and (if we haven't done so already) we will contact the referees you have nominated. You will also be asked to complete a health declaration so that you can tell us about any health conditions or disabilities for which you may need us to make appropriate adjustments.
