#### The role

The post holder will provide support to clinical research studies initiated by the MDUK Oxford Neuromuscular Centre or in which the Centre is an active partner. The role, supervised by the Senior Research Physiotherapist, Charlotte Lilien, will require liaison between members of the Oxford University Hospitals (OUH), the Department of Paediatrics, the Nuffield Department of Clinical Neuroscience (NDCN) and the MDUK Oxford Neuromuscular Centre (ONMC).

The post holder will actively support the development of clinical trials in Prof. Laurent Servais' research group, STRONG, and will be responsible for the assessment of patients participating in national and international clinical trials, natural history studies, and assessment within standard of care. These include both children and young adults with a variety of neuromuscular conditions, including DMD, SMA, and LGMDs as well as other neurological conditions. They will take part in assessment of material selection, maintenance and updating. As a research physiotherapist, they will be primarily based at the John Radcliffe Hospital.

This post is to cover the absence of the substantive postholder, who is taking a period of reduced hours. The post is available until 30 September 2025 or the return of the substantive postholder, or the resignation of the substantive postholder and employment of a new postholder, whichever is the earliest

## Responsibilities

- To carry out assessment of neuromuscular patients as an autonomous practitioner, including those with diverse or complex presentations / multiple pathologies; using clinical reasoning skills, and knowledge of evidence-based practice.
- To interpret and analyse clinical and non-clinical facts to assess potential neuromuscular disorders including those with a complex presentation, with guidance from the senior physiotherapist.
- To keep abreast of evidenced based practice and emerging research in the neuromuscular field and to ensure a good working knowledge of national standards for the care of neuromuscular patients.
- To have knowledge of and be proactively involved in industry led and therapy led research
  opportunities, developing research skills, database management and national
  presentation skills to a highly specialised level.
- To maintain CPD portfolio and demonstrate commitment to own professional development.
- To maintain accurate electronic/paper records in line with professional standards.
- To be able to manage potentially stressful, upsetting or emotional situations in an empathetic manner alongside demonstrating the ability to communicate often complex and sensitive information to patients, carers and other staff, where there may be barriers to communication (non-English speakers or those with communication disorders).
- To establish and maintain positive interpersonal relationships with other team members, characterised by open communication, trust and respect.
- To carry out all duties in accordance with the requirements of the Health Care and Professionals Council and Oxford University Hospitals Trust policies and procedures.
- To exercise a personal duty of care with expensive equipment provided and to ensure designated staff are competent prior to use. Furthermore, to contribute to the maintenance of small materials where appropriate.
- To inform any concerns for competent use, repair and maintenance reporting of all electrotherapy equipment, gym equipment and patient appliances used as indicated and to monitor use of supplies for research activities and advise when supplies are required.
- To provide support for the provision of specialised teaching to peers and junior staff; this may include large groups.

• To be professionally and legally responsible for all aspects of their own work.

#### Selection criteria

#### **Essential**

- Diploma/Degree in Physiotherapy.
- Evidence of HCPC registration.
- Some experience and/or knowledge in neuromuscular disorders
- Experience in working with children
- Keen to develop a research career in neuromuscular disorders.
- Excellent communication and interpersonal skills, as well as motivation and enthusiasm for providing an excellent service.
- Organisation and time management skills, with an ability to maintain judgement under pressure.
- Commitment to personal and team development, with evidence of ongoing professional development and an ability to pass on skills and knowledge to others in both formal and informal environments.
- Ability to work collaboratively within a multidisciplinary team.
- IT and presentation skills, understanding of research and audit.

#### **Desirable**

- Evidence of NHS experience.
- Experience in treating neuromuscular disorders as a physiotherapist.
- Awareness of the Children's Act, child protection issues and procedures, and education policies in respect of children with special needs.
- Experience of writing reports.
- Understanding of clinical governance and good clinical practice.
- Current full driving licence.

# Specialised Translational Research Oxford Neuromuscular Group (STRONG)

STRONG is led by Laurent Servais, Professor of Paediatric Neuromuscular Diseases. Staff are based within a suite of offices in the academic centre on the third floor of the John Radcliffe Hospital in Headington, Oxford. This rapidly growing research group focuses on paediatric neuromuscular diseases and driving research into early identification, potential treatments, and early intervention for rare disorders.

Major focuses of the group include gene therapy – it is co-lead of a WP in a European Project to evaluate potential marker of gene therapy toxicity in humans – as well as neonatal genetic screening, with the implementation of the first genetic population-based screening in the UK for spinal muscular atrophy being one of its proudest recent achievements. The group is also leading an ambitious program of research into Angelman syndrome, with clinical trials and a natural history study ongoing.

The Department of Paediatrics is a world leader in child health research and hosts internationally renowned research programmes in drug development, gastroenterology, haematology, HIV, immunology, neuroimaging, neuromuscular diseases and vaccinology.
