About Oxford Population Health

Oxford Population Health (the Nuffield Department of Population Health) provides an excellent environment for multi-disciplinary research and teaching and for professional and support staff. In addition to its research activities, the Department is home to the [MSc in Global Health Science and Epidemiology](#), the [MSc in Clinical Trials](#), and a variety of short courses. Students also come to undertake research for [DPhil degrees](#). Teaching is provided for undergraduates reading for Medicine and for public health doctors in specialist training.

The role

You will be part of the NDPH Wolfson laboratory's specialist assay laboratory, reporting to the Laboratory's Research Fellow and will be expected to work effectively with a range of colleagues within the department as well as external collaborators. You will fulfil a representational role, dealing directly with individuals internally (i.e. Researchers and Laboratory Staff) and externally (i.e. instrument manufacturers and application specialists) to ensure a continuous high level of service.

Responsibilities

- Manage the day-to-day running, maintenance and sample analysis of the NDPH Wolfson laboratory NMR metabolomics facility. This includes workload planning, staff scheduling and managing the automated liquid handling workstations used to prepare samples for NMR analysis.
- Actively support proposals and research objectives requiring NMR analyses, by developing and implementing experimental protocols, for the NDPH's programmes of research and for collaborative projects, acting as a primary point of contact.
- Train and supervise staff when using the NMR facility and associated equipment.
- Responsible for documentation supporting all aspects of running the NMR metabolomics facility to ensure compliance with regulatory and accreditation bodies and local safety regulations. This includes SOPs, COSHH and maintenance and operation of equipment.
- Be responsible for validating methods and monitoring assay performance against appropriate standards (including ISO 17025:2017).
- Managing service contracts and the specialist consumables for the NMR facility .
- Provide cost information for internal and collaborative research projects and to monitor expenditure related to assays.
- Provide support for other projects based in the specialist assay laboratory using automated liquid handling methods.

- Work closely with senior NDPH investigators and external collaborators, participating in scientific discussions, including presenting technical reports and results at external meetings/seminars. Prepare test reports and support NDPH investigators and statisticians with explanation and interpretation of analytical data and manuscript publication.

The above list is not exhaustive and the role-holder is required to undertake such duties as may reasonably be requested within the scope of the post. All staff are required to act in a professional, cooperative and flexible manner, in line with the requirements of the post.

Selection criteria

Essential

- Hold a PhD (or close to completion of) in a life science.
- Relevant experience of NMR or significant academic or industrial experience relevant to the post.
- Experience in the application and interpretation of NMR techniques with a good understanding of the problems of sample characterization and knowledge of metabolomics.
- Track record in reporting and disseminating NMR output to different audiences including at scientific meetings, through scientific reports, and contributing to grant applications.
- Proven organisation and project management skills. Ability to design projects, prioritise work, manage time effectively and make operational decisions.
- Excellent interpersonal skills to work in a team, communicate with people at all levels, and ability to supervise and train staff.
- Good oral and written communication skills. You will be required to convey information clearly and accurately at different levels of complexity.
- Proven experience of costing and managing finances for research projects.
- Good IT skills, including use of bioinformatics software and databases for integration, analysis and reporting of data.

Desirable

- Experience of working with Bruker NMR instrumentation and software.
- Experience of working with automated liquid handling workstations.
- Knowledge and understanding of ISO accreditation in a laboratory environment.
- Expertise in using electronic database management systems to display, control and review documents.
- Computer programming experience.

Pre-employment screening

Standard checks
