The role

The Accelerate Hub at the Department of Social Policy & Intervention, University of Oxford, is seeking a Research Assistant to contribute to the analysis and economic modelling of adolescent development accelerator interventions in Africa. The selected candidate will work closely with the Economic Evaluation Research Team (EERT) to conduct comprehensive reviews of literature and perform descriptive and inferential statistical analyses. This position offers an excellent opportunity for individuals with a background in development economics and/or global health who have a keen interest in adolescent research.

At the EERT, we conduct economic decision modelling of combinations of 'accelerator' interventions, including economic strengthening (e.g., cash transfers), sexual and reproductive health services, and parenting support. Our research is carried out in close collaboration with international agencies such as UNICEF, WHO, and PEPFAR. The goal is to support policymakers in selecting the most cost-effective interventions for improving the wellbeing of adolescents in developing countries.

The selected candidate will work at the Accelerate Hub, Department of Social Policy & Intervention, University of Oxford. This position can be either part-time or full-time, depending on the candidate's availability and preferences. It is a fixed-term position until 31st March 2025, with the possibility of extension based on funding availability.

Responsibilities

- **Literature review:** Conduct thorough literature reviews on existing impact and economic evaluations of adolescent development accelerator interventions. This includes writing review protocols, identifying key studies, extracting quantitative data (such as effect estimates, p-values), and summarizing findings.
- **Support cost-effectiveness analyses:** Assist in designing and implementing rigorous cost-effectiveness analyses of development interventions, with a special emphasis on multi-outcome interventions.
- **Support economic modelling:** Assist in applying economic decision modelling methods to assess the impact and economic return of combinations of accelerator interventions to improve multiple outcomes.
- Data collection and analysis: Collect data from secondary sources, including information about program
 costs and outcomes. Utilize statistical and econometric techniques to derive meaningful insights from
 quantitative data.
- **Research support:** Provide comprehensive research support to the project team, including data cleaning, literature synthesis, drafting research reports, and assisting with presentations or academic papers.
- **Documentation and reporting:** Document research processes, methods, and findings in a clear and organized manner. Prepare high-quality reports, summaries, and presentations for internal and external dissemination.

Selection criteria

Essential selection criteria

- Education: Hold a first degree and/or Master's degree in Economics, Global Development Studies, Public Policy, or a related field. Candidates in the final stages of completing their degree will also be considered.
- **Knowledge:** Strong working knowledge of impact and economic evaluation methods, including cost-effectiveness analysis, and intermediate microeconomics.
- **Research skills:** Demonstrated experience in conducting quantitative research, including data collection, cleaning, and analysis. Proficiency in statistical software packages (e.g., R, Stata) is preferred.
- Analytical mindset: Excellent analytical and critical thinking skills, with the ability to interpret complex data and derive meaningful insights. Attention to detail and accuracy in data analysis is essential.
- **Communication:** Strong written and verbal communication skills in English, with the ability to convey research findings effectively to diverse audiences.
- **Team player:** Proven ability to work effectively in a collaborative research environment, contributing to a positive and inclusive team culture.
- Organisational skills: Excellent organisational skills, with the ability to prioritize tasks, manage time
 efficiently, and meet deadlines.
- **Initiative:** Self-motivated and proactive, with a willingness to take ownership of tasks and show initiative in problem-solving.
- Passion for development research: A genuine interest in the field of development economics and a commitment to improving the social wellbeing of vulnerable social groups in Sub-Saharan Africa.

Desirable selection criteria

- Familiarity with evaluation frameworks, cost-benefit analysis, and cost-utility analysis is desirable.
- Experience in writing research reports, academic papers, or policy briefs is advantageous.
- Working toward a doctorate in a relevant specialist discipline.
- Experience of working in a research team and contributing ideas for new research projects.

Department of Social Policy and Intervention

The Department of Social Policy and Intervention is a multidisciplinary, social science centre of excellence for research and teaching in comparative social policy and evidence-based social intervention and policy evaluation. In the UK-wide 2021 Research Excellence Framework (REF), it was a top-five scoring department in the country, across all subjects and universities, with 62 per cent of the Department's research activity classified as 'world leading' (4*) with a further 30 per cent classed as 'internationally excellent' (3*). In the most recent QS World University Rankings by Subject (2022) the Department ranked second in Social Policy and Administration globally.

The Department has undergone substantial transformation in recent years. This renewal includes the expansion of graduate teaching and supervision in policy evaluation and comparative social policy; significant expansion in research income; and the creation of new research groups and areas of research expertise.

The Department's teaching is largely devoted to graduate students. It offers master's degrees in Comparative Social Policy (CSP) and in Evidence-Based Social Intervention and Policy Evaluation (EBSIPE). Students may study for either

a one-year MSc or a two-year MPhil. The Department also offers supervision for doctoral degrees in Social Policy or in Social Intervention and Policy Evaluation. The graduate intake is highly international with students drawn from the United Kingdom, EU member states, and many countries across the world.

The Division has an extensive portfolio of external funders, partners, and supporters, with competitively awarded external research income exceeding £50 million per year and philanthropic income over £25 million a year. As part of our commitment to equality of opportunity, eight of our departments have achieved bronze Athena SWAN awards: the Blavatnik School of Government, Economics, Education, International Development, Law, Geography & the Environment, Anthropology & Museum Ethnography, and the Said Business School, with all our other departments either in the process of applying or scheduled to do so shortly.
