## About Oxford Population Health

Oxford Population Health (the Nuffield Department of Population Health) provides an excellent environment for multi-disciplinary research and teaching and for professional and support staff. This comprised research from Oxford Population Health and research from the Nuffield Department of Primary Care Health Sciences. We scored particularly well for having an environment that is conducive to producing research of world-leading quality and enabling outstanding impact, in terms of its vitality and sustainability.

In addition to its research activities, the Department is home to the <u>MSc in Global Health</u> <u>Science and Epidemiology</u>, the <u>MSc in Clinical Trials</u>, and a variety of short courses. Students also come to undertake research for <u>DPhil degrees</u>. Teaching is provided for undergraduates reading for Medicine and for public health doctors in specialist training.

# The role

We are seeking a highly motivated medical statistician to join an established multidisciplinary team, led by Professor Jemma Hopewell. The group focuses on research into cardiovascular precision medicine by capitalising on large-scale data to identify the causes, consequences and treatments for coronary disease, stroke and arrhythmias. The research is supported by established big data resources (e.g. clinical, genetic, proteomic, imaging, record linkage) from various epidemiological studies and population biobanks, randomized controlled trials, as well as academic and industry collaborations.

The successful applicant will work on cutting-edge population health research using largescale –omics and multi-modal data from randomized and observational studies. This is an exciting opportunity to further develop their statistical and -omics expertise and contribute to high impact cardiovascular research. The role will focus on maximising the value of new and existing resources to develop our understanding of the relationships between cardiovascular phenotypes, comorbidities, and therapies. You will adopt state-of-the-art techniques to conduct precision medicine research that will elucidate our understanding of the complexities of cardiovascular disease and patient profiles, and the relevance for treatment choices and patient outcomes.

## Responsibilities

Under the overall supervision of your senior academic lead, you will:

- Contribute to statistical analysis of large-scale/multi-dimensional data, by adopting appropriate methods (e.g. regression modelling, machine learning) and contribute to interpretation of the results.
- Write efficient and flexible statistical code (e.g. using R, SAS, Python), and contribute to a library of shared code.
- Keep and maintain well-structured and comprehensive records of analyses and results.

- Prepare high quality tables and figures for publications and study reports, in collaboration with other group members.
- Contribute to preparation and drafting of manuscripts for publication.
- Contribute to regular team meetings, and wider meetings, and present your work to others.

The above list is not exhaustive and the role-holder is required to undertake such duties as may reasonably be requested within the scope of the post. All staff are required to act in a professional, cooperative and flexible manner, in line with the requirements of the post.

# **Selection criteria**

## Essential

- Postgraduate qualification in statistics/mathematics/data science or closely related highly quantitative subject.
- Knowledge and experience of analysing healthcare/genetic/imaging data from largescale population biobanks and/or randomized controlled trials, and interpreting results.
- Proficiency in code development (e.g. R, SAS, Python) for processing and analysing large-scale health data.
- Ability to work effectively independently and to collaborate as part of a multidisciplinary team, with excellent communication and interpersonal skills.
- Ability to manage time appropriately across projects to meet deadlines, working with meticulous attention to detail and high levels of accuracy.

## Desirable

- Experience of undertaking analyses using various machine learning methods.
- Experience of working with high performance computing resources / cloud computing platforms (e.g. DNANexus), and working in both Linux and Windows environments
- Research experience in cardiovascular disease and population health research.

## Standard checks
