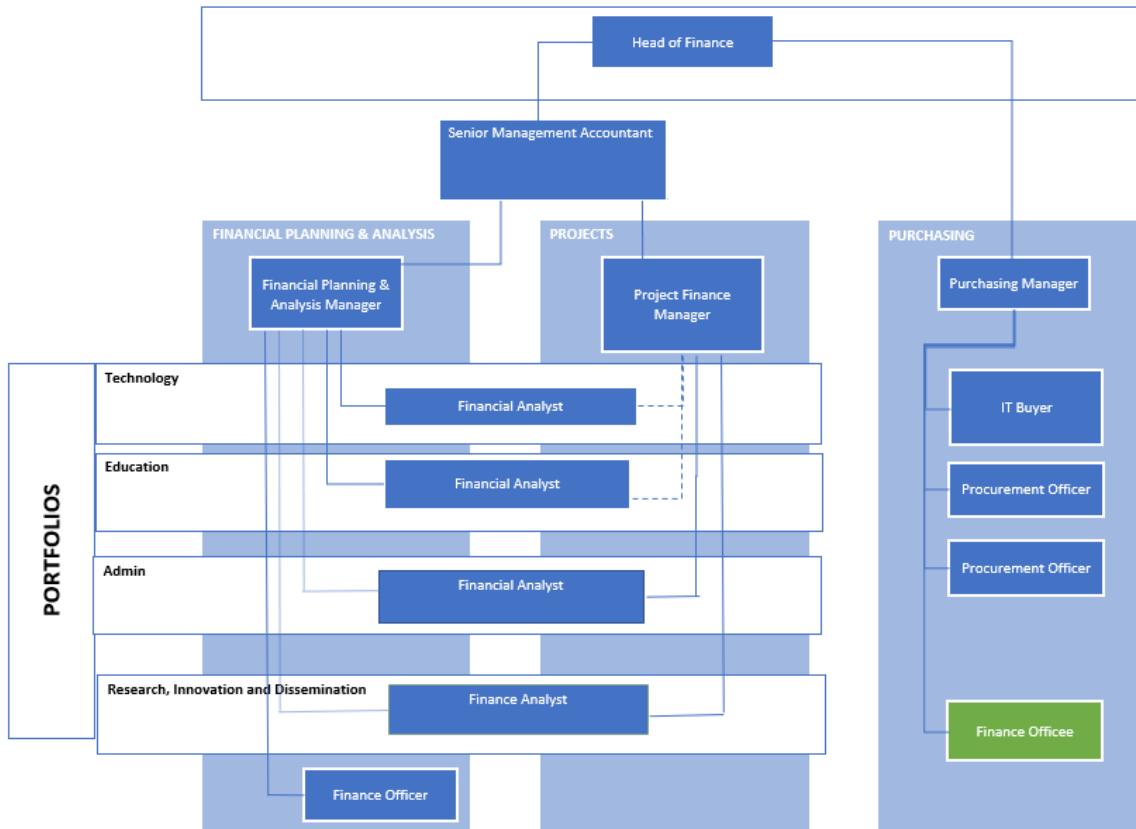

The role

Overview of the role

The finance team sits within the Office of the CIO and has a dotted line into Central Finance, via the Divisional Financial Controller for UAS and GLAM. In order to meet the changing needs of the department, the finance team is gradually being reorganised to support a product lifecycle model of operation, as show in the following organisation chart:





The role, highlighted in green in the current IT Services Finance structure, sits within the Purchasing Team. It reports directly into the Purchasing Manager. This team manages all aspects of the P2P process and provides a purchasing service to third parties and supported departments in the University. The post will report on a day to day basis to the Purchasing Manager.

Responsibilities

- Deliver accurate and timely day-to-day transactional workload, month-end processing, and any additional year-end accounting requirements in line with the financial procedures and policies of the University. Including, but not limited to –
 - Convert Request Tracker customer requisitions into Purchase Orders in Oracle
 - Enter Request Tracker goods receipt notes into Oracle
 - Coordinate Request Tracker and ensure that all requests have been fulfilled weekly.
 - Input invoices and credit notes on Oracle and associated systems
 - Conduct 3-way matching checks
 - Prepare and post journals, ensuring adequate back-up information is retained
 - Reconcile the E20101 purchasing suspense account each month end
 - Deal with queries associated with the purchase to payment cycle
 - Regularly review open purchase orders and address any issues.
 - Regularly review invoices on hold, highlighting any concerns to the Purchasing Manager.
 - Respond to enquiries, regularly providing advice on financial procedures and policies.

Procurement and contract management

- Assist with supplier financial appraisals where required.
- Conduct cost and spend analysis across the department to inform future procurement decision making, general ledger projections, and capital project planning.
- Work with the Purchasing Manager and IT Buyer to create, maintain, and monitor a robust contract management process.

Purchasing analysis and reporting

- Gather and enter data to our vendor management solution. Use this, and other data sources, to provide insightful analysis and reporting.
- Work with the Business Management team to maintain the IT Asset Log.
- Support the Purchasing Manager and the IT Buyer in administering our growing AWS and Azure estate. Transacting recharges, distributing reporting, and responding to queries on a regular basis.

Other

- Work with the rest of the finance team to deliver team objectives.
- Contribute towards the continual development and implementation of departmental financial processes and procedures.
- Participate in the regular PDR process and undertake any necessary training identified.
- Any other duties commensurate with the grade of the post as directed by the Purchasing Manager or Head of Finance.

Selection criteria

Essential

- Previous experience of Financial systems in a complex organisation.
- Strong Excel skills, including pivot tables and complex formulae.
- Good analytical skills, including confidence in extracting and manipulating data.
- An ability to establish and maintain relationships to a high level of effectiveness and gain confidence from a wide range of stakeholders.
- High levels of personal effectiveness - particularly co-ordination, organisation, and the ability to focus on achieving deadlines.
- A strong desire and ability to maintain a very high level of accuracy in the role.
- High levels of personal effectiveness, and integrity.

Desirable

- Previous experience of Accounts Payables and/or Purchasing.
- Financial or accounting qualifications, or working towards obtaining them.
- An interest in Procurement.
