The role

Reporting to Dr Anders Bach-Mortensen and Dr Benjamin Goodair, Co-Investigators, the Postdoctoral Researcher will support a Nuffield Foundation funded project on the outsourcing of adult and children's social care in England – evaluating the impact of marketisation, for-profit provision, and privatisation of social care services, producing research on what it means for service users' outcomes, quality of care, and accessibility of care.

The role involves analysing a novel data resource of harmonised publicly available data on local authorities and adult and children's social care providers in England.

Responsibilities

 Conduct and contribute to high quality research on the outsourcing of adult and children's social care;













- Clean, analyse and visualise data, interpret the results reviewing and refining theories as appropriate;
- Identify and merge relevant datasets, developing new computational methodologies and processes;
- Manage own research and administrative activities, including small scale project management;
- Represent the research group, presenting papers at external meetings/seminars, either with other members of the group or alone;
- Contribute to wider project planning and research grant writing;
- Lead and contribute to the writing and formatting of research papers and project deliverables;
- Act as a source of information and advice to other members of the group on methodologies or procedures
- Responsible for the day-to-day administration of the research project;
- Contribute ideas for new research projects, and develop ideas for generating research income;

Selection criteria

Essential selection criteria

- Hold, or be close to completing, a relevant PhD/Dphil, together with relevant experience.
- Experience with quantitative data analysis.
- Experience working with quantitative data management, analysis, and visualisation.
- Ability to manage own research and administrative activities.
- Excellent communication skills, including the ability to write text that can be published, present data at conferences, and represent the research group at meetings.

Desirable selection criteria

- Experience working with administrative health or social care data.
- Experience with merging routinely collected administrative data.
- Knowledge of outsourcing literature and theory.
- Knowledge of statistical software R or Stata.
- Experience of conducting peer-reviewed research related to health and social care.
