#### The role

The post holder will join a large group of researchers at the Oxford Vaccine Group, conducting major national and international studies of vaccines for children and adults.

We seek a self-motived Statistician/Data Scientist/Bioinformatician with an interest in vaccines or infectious diseases, to join our large team of bioinformaticians, epidemiologists and statisticians.













This position will suit a candidate with background in either medical statistics, health data science, bioinformatics, or computational biology, with projects adjusted to suit the skills and research focus of the applicant. We have multiple projects available supported by a current team of 12 people. Projects range from early phase clinical trials of new vaccines to multi-omics approaches to elucidating protective immune responses to vaccines.

Applicants at grade 6 would be expected to have a Masters degree in one of the above disciplines, and training would be provided to expand your skills and experience.

The post holder will be responsible for drafting peer reviewed publications from their work with the opportunities to lead as first author and present findings at relevant conferences. Additionally, there will be opportunity to attend further training in statistical or bioinformatics methods. For selected candidates who are successful in this role, there is the potential to apply for a future PhD position as part of their role within the department with an 80% reduction in fees, subject to departmental approval.

To succeed in this post you will have excellent communication skills and a commitment to writing high quality manuscripts which present important scientific findings with clarity. Strong analytical skills, an enquiring and flexible attitude, and an interest in working collaboratively with researchers from different disciplines will also be important components for success.

### Flexible working

This post is offered all full time with an opportunity for partial remote working. Flexible working arrangements may be considered.

# Responsibilities

- Conduct detailed analysis of datasets for assigned studies;
  - For those with a bioinformatics focus this may include using various classification and/or feature selection approaches to down-select a small set of promising biomarkers from a larger dataset or analysing multi-sample datasets from proteomics and RNA-seg studies.
  - For those with a statistics focus, linear or logistic regression models and standard statistical methods for analysing data from clinical trials or observational studies would be required.
- Develop statistical analysis plans for studies and contribute or the planning of day to day work
- Develop or tailor analytical tools and resources appropriate to the work such as programming code in R or other coding platforms.
- Write up statistical analysis and results or contribute to peer reviewed publications, presentations and other means of disseminating results.
- Attend scientific conferences, seminars, meetings, and training as appropriate.
- Develop or tailor analysis tools and resources in collaboration with members of the research team, to streamline analysis pipelines.
- Identify and troubleshoot technical or scientific problems, working collaboratively with database experts and scientific programmers.

- Contribute ideas and communicate effectively with database experts and scientific programmers.
- Participate in the wider work of the Oxford Vaccine Group, such as journal clubs, weekly meetings, such as the Big Data Cub, and the training and development of junior staff.

#### Selection criteria

#### **Essential**

- A degree in a relevant subject and a post-graduate degree in Mathematics, Statistics, Bioinformatics, Computational Biology, or a related subject.
- Demonstrable experience, ability and practical success in statistics or bioinformatics.
- Proficiency in the use of statistical programming languages.
- Demonstrable ability to organise and prioritise work efficiently whilst delivering results to the required standard and to an agreed schedule.
- Ability to draft sections of reports or manuscripts for publication and present statistical results at conferences or to internal groups.
- Strong communication skills, including the ability to communicate statistical/computational concepts clearly to a non-statistical audience.
- Ability to work well in a multi-disciplinary team.
- Ability to work to tight deadlines calmly and efficiently.
- Commitment to training and developing new skills and methods where needed.

#### **Desirable**

- A PhD (or equivalent) in a relevant scientific subject such as statistics, bioinformatics, data science, or computational biology.
- Previous research experience analysing clinical or immunological datasets.
- Proven track record of contributing to publications.
