### The role

The Programme for Global Leadership (which includes the Oxford Character Project) at the Department of Politics and International Relations (DPIR) is seeking a dynamic and experienced Partnerships and Communications Officer to support a strategic fundraising campaign. The successful candidate will work closely with internal and external stakeholders, including the Programme's team, an external consultant, key advisors, ambassadors, and the Oxford University Development Office, to deliver a major fundraising campaign. This is a unique opportunity to contribute to the future of a transformative initiative at the intersection of leadership research, leadership education and character development.

The post holder will be responsible for supporting all aspects of the campaign, including developing a high-quality communications assets, engaging alumni, producing a regular

















newsletter, planning and organising campaign events and meetings, tracking and measuring progress, The role will also include managing logistics and other administrative tasks relevant to making the campaign a success.

### Responsibilities

- Develop high quality communications assets and tailor materials for specific target audiences
- Oversee the development of new web content and manage regular website updates
- Develop and manage a campaign database to keep track of contacts and campaign activities
- Build an active alumni network
- Equip campaign ambassadors with relevant resources to convey the campaign's goals, liaising with them to provide support
- Manage all social media and website communications for the Programme for Global Leadership
- Plan and oversee high profile meetings and events in Oxford and other locations globally, liaising with guests and internal stakeholders, and ensuring events are delivered with the highest attention to detail
- Schedule meetings and arrange travel bookings for the Director / PI to support the fundraising efforts
- Monitor project budgets
- Undertake any other administrative tasks commensurate with the grading of the post, as may be required and within the time available.

- Excellent interpersonal skills to communicate with a wide range of people from different backgrounds, levels of expertise, and seniority, inspiring the confidence and trust of donors and partners
- High level of proficiency in the use of MS Office, Canva (or similar design platforms), Video-editing software, social media, and Internet resources.

## The University's policy on retirement

The University operates an Employer Justified Retirement Age (EJRA) for very senior research posts at **grade RSIV/D35 and clinical equivalents E62 and E82**, which with effect from 1 October 2023 will be 30 September before the 70<sup>th</sup> birthday.
