Oxford Population Health (the Nuffield Department of Population Health) provides an excellent environment for multi-disciplinary research and teaching and for professional and support staff. In addition to its research activities, the Department is home to the [MSc in Global Health Science and Epidemiology](#), the [MSc in Clinical Trials](#), and a variety of short courses. Students also come to undertake research for [DPhil degrees](#). Teaching is provided for undergraduates reading for Medicine and for public health doctors in specialist training.

The role

We are seeking a Study Coordinator to co-ordinate, manage and facilitate the expansion of enhancements to UK Biobank, which is an open-access biomedical research resource involving half a million participants.

You will be responsible for managing the delivery of a variety of projects and will be the primary point of contact for all operational issues. You will be expected to work on multiple projects at the same time and will need to work flexibly to accommodate changing priorities of the overall study.

Examples of projects that you will be involved in include:

- The re-assessment of all UK Biobank participants to collect repeated physical measures and biological samples; and
- The collection of new data on brain health from participants with neurodegenerative conditions.

You will work closely with a multi-disciplinary team of epidemiologists, administrators, IT staff, data analysts, project managers, and other senior management in UK Biobank and elsewhere. You will be based within the UK Biobank Scientific Study Development Group and will report directly to the Scientific Study Development Group Lead of UK Biobank, based in Oxford Population Health, University of Oxford.

Responsibilities

- Scoping out, developing and delivering major new enhancements to UK Biobank. This will include assessing feasibility, developing project requirements, and significantly contributing to development of project plans and project management.
- Organising study working groups and liaising with internationally recognised subject area experts to seek advice when developing projects. The postholder will organise internal and external group meetings, set agendas and relay meeting minutes.
- Developing project materials. This will include, but is not limited to, participant-facing materials (electronic, paper and video), web content and documents for submission to ethics committees.

- Facilitating the set up and sending of project mailing campaigns required for projects (e-mail, postal and SMS), including liaising with the UK Biobank Contact Centre and administrative teams to ensure appropriate content and mailing rates.
- Working with the UK Biobank IT teams to facilitate the setup of electronic study documentation, such as consent forms and questionnaires.
- Taking responsibility for monitoring project response rates, and for reporting these to senior management, funding bodies, committees, collaborators, and other relevant organisations, as required.
- Keeping senior staff abreast of any issues or changes affecting the development and implementation of projects and seek to find solutions to any issues that occur.
- Taking responsibility for ensuring that all study documents such as Standard Operating Procedures, User Requirements Specifications, training and user manuals, and any other appropriate documentation are developed, kept up to date and stored in a consistent, standardized and secure fashion.
- Line managing the UK Biobank Systems Analyst, This will include managing workload, reviewing performance and conducting personal development reviews.
- Liaising with other similar studies/research groups, to facilitate the development and implementation of best research practice.
- Where relevant, taking responsibility for monitoring and reporting of adverse events to the appropriate bodies.
- Under the direction of the Scientific Study Development Group Lead, undertaking methodological research to determine best practice for UK Biobank projects.
- Contributing to publications and presentations, as appropriate. ?
- Deputising for the Scientific Study Development Group Lead, as appropriate.

The above list is not exhaustive and the role-holder is required to undertake such duties as may reasonably be requested within the scope of the post. All staff are required to act in a professional, cooperative and flexible manner, in line with the requirements of the post.

Selection criteria

Essential

- Hold a postgraduate degree in a relevant subject
- Proven experience in health research study administration
- Experience in a research management role
- Proven ability to show initiative, be pro-active and work without supervision
- Proven ability to collaborate within an interdisciplinary team and work independently

- Proven ability to identify, negotiate and logically resolve complex issues and problems
- Excellent interpersonal and communication skills, particularly when liaising with individuals in different locations and of different seniority
- Excellent organizational and planning skills with the ability to work on multiple tasks and prioritise work effectively

Desirable

- Understanding of epidemiological or large scale cohort study research methodology
- Experience of writing research materials and making arrangements for data gathering
- Experience and understanding of issues related to dealing with confidential data

Pre-employment screening

Standard checks

If you are offered the post, the offer will be subject to standard pre-employment checks. You will be asked to provide: proof of your right-to-work in the UK; proof of your identity; and (if we haven't done so already) we will contact the referees you have nominated. You will also be asked to complete a health declaration so that you can tell us about any health conditions or disabilities for which you may need us to make appropriate adjustments.

The supporting statement must explain how you meet each of the selection criteria for the post using examples of your skills and experience. This may include experience gained in employment, education, or during career breaks (such as time out to care for dependants).

All applications must be received by **midday** UK time on the closing date stated in the online advertisement.

If you currently work for the University please note that:
