About Oxford Population Health

Oxford Population Health (the Nuffield Department of Population Health) provides an excellent environment for multi-disciplinary research and teaching and for professional and support staff. We work together to answer some of the most important questions about the causes, prevention and treatment of disease.

The Department has around 1000 staff, students and academic visitors working in a number of world-renowned population health research groups, including the Clinical Trial Service Unit and Epidemiological Studies Unit (CTSU), the Cancer Epidemiology Unit (CEU), the National Perinatal Epidemiology Unit (NPEU) and other groups working on public health, health economics, ethics and health record linkage. This comprised research from Oxford Population Health and research from the Nuffield Department of Primary Care Health Sciences. We scored particularly well for having an environment that is conducive to producing research of world-leading quality and enabling outstanding impact, in terms of its vitality and sustainability.

In addition to its research activities, the Department is home to the <u>MSc in Global Health</u> <u>Science and Epidemiology</u>, the <u>MSc in Clinical Trials</u>, and a variety of short courses. Students also come to undertake research for <u>DPhil degrees</u>. Teaching is provided for undergraduates reading for Medicine and for public health doctors in specialist training.

The role

The diseases which cause dementia can begin up to 20 years before symptoms show. Early detection is essential both for enabling the deployment of therapeutic responses before substantial nuerodegeneration occurs and to enable research into disease progression. Remote digital technologies such as apps and wearables which collect behavioural and physiological measures relevant to disease progression have great potential. The EDoN Initiative (Early Detection of Neurodegeneration) was set-up by Alzheimer's Research UK has deployed a suite of novel app-based and wearable technologies to measure cognition, behaviour, sleep and physiological changes in cohorts around the world. With the clinical phase nearing completion, this project is an exciting opportunity to be part of an interdisciplinary team with responsibility for harmonizing the data, linking with traditional phenotypes from clinical assessments, biomarkers, and imaging, and beginning analysis. The ultimate aim for EDoN is to create a powerful open multi-modal dataset for global research. Your role will be to create and run transforms which link and harmonise data into agreed schema and calculate standardised featuresets.

Responsibilities

- Maintain data within Secure Research Environment (SRE)
- Collaborate with cohorts around the world to produce harmonised clinical data
- Link multiple digital and clinical data sets from multiple sources
- Clean data and develop appropriate schemas
- Create and run code, or deploy pre-existing pipelines to calculate appropriate feature sets across multiple data modalities
- Transform data so that it is ready for analysis
- Work with data scientists and clinicians to develop models and run statistical analyses

- Contribute to academic papers
- Produce plans and documentation including:
 - o data preparation and anonymisation plan
 - o data harmonisation plan
 - o data linkage plan
 - o data dictionary
 - o data completeness report
- Follow good information governance practices

- Working familiarity with packages such as Pandas, Numpy, SciPy and Scikit-learn
- Strong understanding of data typing, data structures, data schemas, and data stoage formats
- Able to use a Secure Research Environment (SRE) for data processing and analysis
- Experience using/processing large or complex datasets
- Good mathematical and statistical knowledge
- Strong analytic skills, problem solving ability, and attention to detail
- Excellent written and verbal communication skills
- Ability to work independently and to show initiative.
- Able to collaborate and communicate effectively within a multidisciplinary team
- High levels of work organisation, self-motivation, drive for performance and improvement, flexible in approach and manner

- Data science experience using R
- Working knowledge of Java and Spark

Standard checks
