About Oxford Population Health

Oxford Population Health (the Nuffield Department of Population Health) provides an excellent environment for multi-disciplinary research and teaching and for professional and support staff. We work together to answer some of the most important questions about the causes, prevention and treatment of disease.

The Department has around 1000 staff, students and academic visitors working in a number of world-renowned population health research groups, including the Clinical Trial Service Unit and Epidemiological Studies Unit (CTSU), the Cancer Epidemiology Unit (CEU), the National Perinatal Epidemiology Unit (NPEU) and other groups working on public health, health economics, ethics and health record linkage. It is also a key partner in the Oxford University's Big Data Institute.

In the 2021 Research Excellence Framework (REF), 96% of the research submitted to Unit of Assessment 2: Public Health, Health Services and Primary Care, was ranked either 4* (world-leading in terms of originality, significance and rigour) or 3* (internationally excellent in terms of originality, significance and rigour). This comprised research from Oxford Population Health and research from the Nuffield Department of Primary Care Health Sciences. We scored particularly well for having an environment that is conducive to producing research of world-leading quality and enabling outstanding impact, in terms of its vitality and sustainability.

In addition to its research activities, the Department is home to the <u>MSc in Global Health Science and Epidemiology</u>, the <u>MSc in Clinical Trials</u>, and a variety of short courses. Students also come to undertake research for <u>DPhil degrees</u>. Teaching is provided for undergraduates reading for Medicine and for public health doctors in specialist training.

The role

The role of the Senior Human Resources Officer is a key position within the administrative structure of the Nuffield Department of Population Health. Working in a HR team of nine, you will interact with staff at all levels in order to deliver accurate, appropriate and timely HR support and documentation to the department.

Responsibilities

- Liaise with the HR Manager and be responsible for all aspects of recruitment, including
 ensuring funding is available prior to posts being advertised; work with Principal
 Investigators to prepare job descriptions and adverts in line with University policies;
 shortlisting, interviewing and acting as a panel chair when appropriate; deal with post
 offers and salary negotiations, ensure all pre-employment checks are complete including
 immigration documentation.
- Manage and develop a member of the HR team to provide a full, efficient, effective and professional HR service to the department, ensuring compliance with statutory and University legislation.
- Provide advice and guidance to managers and staff on all aspects of employment such as recruitment, absence and stress management, performance management, maternity and paternity leave, regradings, end of fixed-term contracts, disciplinary and grievance etc.
- Support managers in managing change within the department, drafting new procedures and handling individual employee relations cases, ensuring compliance with University and MRC policy and working with central HR where necessary.
- Monitor legislative and University policy developments and make written recommendations which inform the strategic planning of the department based on analysis of internal HR data.

- Contribute to the development and delivery of the departmental HR strategy and associated procedures ensuring that they align with University policy e.g. performance development reviews, induction, career development.
- Communicate key HR policy changes to the department and update staff on new regulations within the University, providing briefing sessions for staff as required.
- Run and review the casual and main payroll reports, ensuring all recent payroll changes are accurately reflected in the pay run. Follow up any inaccuracies.
- Support department and university initiatives, projects and priorities e.g. Athena Swan, immigration audits and compliance checking, manage HR projects as they arise, and implement changes arising from revised University HR policy.
- Attend Divisional working groups or committees to build relationships and share best practice.
- Attend appropriate training on employment law, University HR policies and procedures, and their effective implementation at departmental level.

The above list is not exhaustive and the role-holder is required to undertake such duties as may reasonably be requested within the scope of the post. All staff are required to act in a professional, cooperative and flexible manner, in line with the requirements of the post.

Selection criteria Essential

- Educated to degree level or equivalent
- Qualified to CIPD graduate level or above, or have equivalent experience
- Proven experience of managing a human resources operation in a complex organisation
- Experience of building and managing an HR team to deliver an efficient HR service
- Sound knowledge and experience of the application of UK employment law and UKBA regulations with and ability to evaluate risk
- Experience of managing performance management cases and providing guidance to managers as required
- Experience of operating HR information systems and producing management information reports
- Ability to deal accurately and confidently with numbers in Excel and using other data analysis skills
- Strong communication skills including the ability to influence and persuade managers both verbally and in writing
- Ability to develop professional and effective working relationships with key stakeholders

Desirable

- HR experience within the University of Oxford or other higher education institutions
- Experience of delivering briefing/training sessions

Pre-employment screening

Standard checks

If you are offered the post, the offer will be subject to standard pre-employment checks. You will be asked to provide: proof of your right-to-work in the UK; proof of your identity; and (if we haven't done so already) we will contact the referees you have nominated. If you have previously worked for the University we will also verify key information such as your dates of employment and reason for leaving your previous role with the department/unit where you worked. You will also be asked to complete a health declaration so that you can tell us about any health conditions or disabilities for which you may need us to make appropriate adjustments.

Your application will be judged solely on the basis of how you demonstrate that you meet the selection criteria stated in the job description.

As part of your application you will be asked to provide details of two referees and indicate whether we can contact them now.

You will be asked to upload a CV and a supporting statement. The supporting statement must explain how you meet each of the selection criteria for the post using examples of your skills and experience. This may include experience gained in employment, education, or during career breaks (such as time out to care for dependants).

Please upload your CV and supporting statement **as PDF files** with your name and the document type in the filename.

All applications must be received by **midday** UK time on the closing date stated in the online advertisement.

If you currently work for the University please note that:

- as part of the referencing process, we will contact your current department to confirm basic employment details including reason for leaving
- although employees may hold multiple part-time posts, they may not hold more than the equivalent of a full time post. If you are offered this post, and accepting it would take you over the equivalent of full-time hours, you will be expected to resign from, or reduce hours in, your other posts(s) before starting work in the new post.

Information for priority candidates

The University operates an Employer Justified Retirement Age (EJRA) for very senior research posts at grade RSIV/D35 and clinical equivalents E62 and E82, which with effect from 1 October 2023 will be 30 September before the 70th birthday. There is no normal or fixed age at which staff in posts at other grades have to retire. Staff at these grades may elect to retire in accordance with the rules of the applicable pension scheme, as may be amended from time to time.
