The role

The Postdoctoral Research Assistant will work on the design and development of a vectorial adaptive optics-enhanced, liquid crystal-based Mueller matrix pathological microscope. Among other activities, this will involve investigating liquid crystal-based systems, intensity adaptive optics techniques, whole-slide imaging/scanning systems, proposing and designing vectorial measurement and polarisation control programs, procuring components, and documenting and reporting findings. This post will involve regular interactions and meetings with others in the group.

Responsibilities

Specific duties:

- Designing components and systems relating to the vectorial adaptive optics-enhanced, liquid crystal-based Mueller matrix pathological microscope.



- Analysis and documentation of experimental programs and designs.
- Interacting with companies and obtaining quotations and components for the facilities.
- Development of experimental measurement and control programs.
- Investigating and designing of experimental hardware, such as polarisation generation and analysis modules.
- Documentation of operational and maintenance procedures along with general findings.
- Perform risk assessments.
- Assist DPhil students to obtain measurements for their research programmes.
- Receive, understand and convey information which needs careful explanation or interpretation.

Additional duties:

- Manage own work and administrative activities, within guidelines provided by senior colleagues.
- Contribute to wider project planning.
- Determine the most appropriate methodologies to test hypotheses, and identify suitable alternatives if technical problems arise.
- Responsible for general laboratory management and administration, including stock control of laboratory consumables.
- Contribute to writing and editing journal and conference papers based on activities.

Selection criteria

Essential selection criteria

- Hold a relevant PhD/Dphil or be near completion* together with relevant experience
- Possess sufficient specialist knowledge in the discipline to work within established research programmes
- Experience in polarisation and phase related adaptive optics technology
- Experience in intensity adaptive optics technology
- Experience in liquid crystal based fast or single-shot Stokes vector/Mueller matrix polarimeter
- Previous experience of contributing to publications/presentations
- Experience in whole-slide imaging/scanning systems
- Ability to contribute ideas for new research projects and research income generation
- Excellent communication skills, including the ability to write for publication, present research proposals and results, and represent the research group at meetings

**please note that 'near completion' means that you must have submitted your PhD thesis.*

Desirable selection criteria

- Experience of independently managing a discrete area of a research project
- Experience of actively collaborating in the development of research articles for publication
- Experience with hardware design and software development of intensity, polarisation and phase adaptive optics control.
- Experience with vectorially structured light generation using liquid crystal based devices

Engineering Science Department

Engineering teaching and research takes place at Oxford in a unified Department of Engineering Science whose academic staff are committed to a common engineering foundation as well as to advanced work in their own specialties, which include most branches of the subject. We have especially strong links with computer science, materials science, medicine and also the Saïd Business School. The Department employs 120 academic staff (this number includes 13 statutory professors appointed in the main branches of the discipline, and 25 full professors); in addition, there are nine visiting professors. There is

an experienced team of teaching support staff, professional services and administrative staff and technicians. The Department has well-equipped laboratories and workshops, which together with offices, lecture theatres, library and other facilities have a net floor area of about 25,000 square metres.

The Department is ranked fifth in the world, and the top European University, in the 2023 *Times Higher Education World University Rankings* for Engineering & Technology. Further information about the Department is available at www.eng.ox.ac.uk.

Teaching

We aim to admit 170-180 undergraduates per year to take a 4-year course leading to the MEng degree in Engineering Science. The course is accredited at MEng level by the major engineering institutions. The syllabus has a common core extending through the first two years. Specialist options are introduced in the third year, and the fourth year includes further specialist material and a major project.

Research

Research in the Department is particularly strong. We have approximately 600 research students and about 250 postdoctoral researchers. Direct funding of research grants and contracts, from a variety of sources, amounts to an annual turnover of approximately £70m.

The results of the seven-yearly UK-wide assessment of university research, REF2021, published on 12th May 2022, demonstrate that the University of Oxford made the highest volume of world-leading research submissions. The Department of Engineering Science had 71% of submissions which met the requirements for the highest grading of 4*(research that is world-leading in terms of originality, significance, and rigour).

Research activities fall into 8 broad headings, though there is much overlapping in practice: Information Engineering (Robotics, Computer Vision and Machine Learning); Control; Thermofluids; Materials and Mechanics; Civil and Offshore; Electrical and Optoelectronic; Chemical and Process; and Biomedical.

The Department of Engineering Science holds a bronze Athena Swan award to recognise advancement of gender equality: representation, progression and success for all.

The Mathematical, Physical, and Life Sciences Division

The Mathematical, Physical, and Life Sciences (MPLS) Division is one of the four academic divisions of the University. In the results of the six-yearly UK-wide assessment of university research, REF2014, the MPLS division received the highest overall grade point average (GPA) and the highest GPA for outputs. We received the highest proportion of 4* outputs, and the highest proportion of 4* activity overall. More than 50 per cent of MPLS activity was assessed as world leading.

The MPLS Division's 10 departments and 3 interdisciplinary units span the full spectrum of the mathematical, computational, physical, engineering and life sciences, and undertake both fundamental research and cutting-edge applied work. Our research addresses major societal and technological challenges and is increasingly focused on key interdisciplinary issues. MPLS is proud to be the home of some of the most creative and innovative scientific thinkers and leaders working in academe. We have a strong tradition of attracting and nurturing the very best early career researchers who regularly secure prestigious fellowships

We have around 6,000 students and play a major role in training the next generation of leading scientists. Oxford's international reputation for excellence in teaching is reflected in its position at the top of the major league tables and subject assessments.
