The role

Reporting to the Principal Investigator, the post holder will be a member of a research group with responsibility for communications and research dissemination for the Border Criminologies research network. This post will incorporate technical and administrative support with research assistance and publication work.

Project summary

Based at the Centre for Criminology at the University of Oxford, Border Criminologies is an international network of researchers, practitioners, and those who have experienced border control. Established in 2013, with funding from the Leverhulme Trust and the European Research Council, Border Criminologies has become the primary global platform and network for research and knowledge exchange on the intersections between criminal justice and border control. It has also given rise to a new academic subfield that bears its name: border criminology. Through showcasing and facilitating interdisciplinary research from around the world, Border Criminologies













contributes to a greater understanding of immigration law and policy, with a particular focus on immigration detention and deportation.

Responsibilities

- Oversee the creation of multimedia resources such as infographics and documentaries.
- Review existing Border Criminologies content and reformat it to be of practical use to organisations working with migration and individuals experiencing migration.
- Responsible for the organisation's monthly newsletter and annual report.
- Ensure that press releases are written and published in reaction to relevant current affairs, in collaboration with the Border Criminologies team. Submit other materials to media where relevant (infographics, etc), opeds and opinion pieces.
- Build and implement social media strategies, generating and publishing daily content on our social media, optimizing Border Criminologies' presence on various platforms, moderating user-generated content, analysing social data, and collaborating with other Associate Directors to disseminate research and coordinate actions.
- Contribute to project planning, the design of research materials, and make arrangements for data gathering.
- Contribute to wider project planning, including ideas for new research projects.
- Manage own research and administrative activities, within guidelines provided by senior colleagues.
- Select, follow, and adapt specialist methodologies to confirm or refute theories, and identify suitable alternatives where information or research material is restricted.
- Gather, analyse, and present qualitative and/or quantitative data from a variety of sources.
- Contribute to research publications, book chapters and reviews.
- Represent the research group at external meetings/seminars, either with other members of the group or alone.
- Contribute to discussions and share research findings with colleagues in partner institutions, and research groups.

Selection criteria

- Hold or be working toward a doctorate or postgraduate degree in criminology, law, or a related social science.
- Possess sufficient specialist knowledge about immigration and border control.
- Ability to manage own research and administrative activities.

- Excellent communication skills, including the ability to write text that can be published, present data at conferences, and represent the research group at meetings.
- Experience of following and adapting social science methodologies.
- Experience of research

Desirable selection criteria

- Experience of contributing to research publications.
- Experience of working in a research team and contributing ideas for new research projects.
- Experience of communications, social media, and disseminating academic research.

Centre for Criminology

The Centre for Criminology is the focal point for criminological studies in Oxford. It is a sub-unit of the Faculty of Law and is located in the St Cross Building.

The Centre currently comprises six tenured academic staff: the Statutory Professor of Criminology (Ian Loader), three Professors of Criminology (Mary Bosworth, Rachel Condry and Carolyn Hoyle), and two Associate Professors (Katrin Muller-Johnson and Leila Ulrich). Professor Lucia Zedner (Senior Research Fellow, All Souls College) is involved in the Centre's teaching and research programmes. The Centre also currently has a Visiting Professor (Dr. Hindpal Bhui), a Visiting Professor of Practice (Parvais Jabbar).

The Centre is also comprised of a number (the exact number varies over time) of post-doctoral researchers (typically funded by the British Academy or Leverhulme Trust), as well as researchers working on externally-funded research projects. At present, there are six postdoctoral researchers working in the Centre. The Centre also runs an active Academic Visitors programme. The Centre's work is supported by two professional support staff: A Graduate Studies Administrator (Abigail O'Regan) and a Centre Administrator (Angela Patterson). The Centre is home to the Death Penalty Research Unit, directed by Carolyn Hoyle, and the international Border Criminologies research network, founded by Mary Bosworth. It also hosts the student-run Oxford Transitional Justice Research network.

At the Oxford Centre, we understand criminology as a 'meeting place' – staff in the Centre are originally trained in history, law, politics and international relations, psychology and sociology. We treat criminology as a field of enquiry where questions of order, justice and control around the globe are brought into conversation with the larger concerns of the social sciences, and social and political theory, with such matters as de-colonialism, gender, political economy, race, and the futures or a climate-changed planet. policy engagement in the Centre can be found <u>here</u>. The person appointed will be expected to play a full and active part in contributing to the Centre's research agenda and profile.

The Centre for Criminology has established a strong reputation over three decades, first for undergraduate teaching and criminological research, latterly also for its graduate criminology programme. Today, the Centre is principally a graduate school. The core of our educational provision is the MSc Criminology and Criminal Justice. The degree has been running for over 20 years and is now well-established with an annual cohort of 28 full-time and 5 part-time students. The Centre offers a thriving DPhil Criminology programme, available both full-time and part-time. At any one time the Centre has a graduate research community of around 40 students. The Centre also teaches an option on 'Criminology and Criminal Justice' on the final (FHS) year of the BA Law degree.

The Centre is housed in dedicated space in the Law Faculty building. Next door is the Social Sciences building www.manor-road.ox.ac.uk - which offers great opportunities for interaction with colleagues from the other Social Science units: Socio-Legal Studies (within the Faculty of Law), Politics and International Relations, and Economics.

Social Sciences Division
