About Oxford Population Health

Oxford Population Health (the Nuffield Department of Population Health) provides an excellent environment for multi-disciplinary research and teaching and for professional and support staff. We work together to answer some of the most important questions about the causes, prevention and treatment of disease.

This comprised research from Oxford Population Health and research from the Nuffield Department of Primary Care Health Sciences. We scored particularly well for having an environment that is conducive to producing research of world-leading quality and enabling outstanding impact, in terms of its vitality and sustainability.

In addition to its research activities, the Department is home to the <u>MSc in Global Health Science and Epidemiology</u>, the <u>MSc in Clinical Trials</u>, and a variety of short courses. Students also come to undertake research for <u>DPhil degrees</u>. Teaching is provided for undergraduates reading for Medicine and for public health doctors in specialist training.

The role

We are looking for an administrative assistant to support the collection, preparation, and analysis of new and existing large-scale wearable sensor datasets. You will be an integral member of the wearables group based at Oxford, led by Aiden Doherty and directly supervised by a postdoctoral researcher in the OxWearables Research Group. There will be exciting opportunities to recruit participants and support collection of new wearable camera and accelerometer datasets with accompanying validation measurements of sleep (polysomnography) and activities of daily living (wearable cameras) in both validation and clinical studies.

Our research team has access to world-leading population health data sets with objective wearable sensor measurements of sleep and physical activity linked to clinical and genomic data. For example, we play a key role in the UK Biobank activity monitoring project, where ~100,000 participants have accelerometer, genomic, hospitalisation, and mortality data collected. You will be based at the Big Data Institute, and be expected to contribute to relevant group meetings and support data generation for current and future clinical and device-validation studies.

Responsibilities

- Conduct data collection in free-living and laboratory environments, including exercise testing in a hospital laboratory in the Oxford area
- Recruit, receive consent, and provide support and follow-up to research participants during study data collection
- Manage and maintain supply of research equipment, facilitating equipment distribution to research participants and relevant collaborating study teams
- Assist with the maintainence of accurate and comprehensive records of data collection and analyses, while conducting quality control to ensure data accuracy and completeness
- Assist with the collection and management of sensitive research data in accordance with research protocols and governance policies, on-site and in fieldwork
- Assist in the annotation of wearable camera images and other sensor data

- Support senior colleagues and collaborators to advance the use of wearable sensors in observational epidemiological studies and regulated clinical trials
- Support the preparation of drafts for scientific reports, posters, and journal articles
- Contribute to the overall department by attending meetings and seminars as appropriate

The above list is not exhaustive and the role-holder is required to undertake such duties as may reasonably be requested within the scope of the post. All staff are required to act in a professional, cooperative and flexible manner, in line with the requirements of the post.

Selection criteria

Essential

- Hold a BSc in health sciences, clinical trials, kinesiology, biomedical engineering or related field
- Strong interpersonal skills for close interaction with prospective and current research participants and PPI groups
- Ability to work co-operatively as part of a team, as well as independently while taking personal responsibility for assigned tasks
- Excellent organisational skills and strong attention to detail, with the ability to accurately record results in a clear and organised fashion
- Willingness to travel and work flexible hours i.e., out-of-hours data collection
- A conscientious and enthusiastic working approach and a high level of reliability

Desirable

- Experience in collecting, cleaning, and analysing sensor or health research data in an academic or clinical environment
- Knowledge of good clinical research practices and regulations

Pre-employment screening

Standard checks

If you are offered the post, the offer will be subject to standard pre-employment checks. You will be asked to provide: proof of your right-to-work in the UK; proof of your identity; and (if we haven't done so already) we will contact the referees you have nominated. If you have previously worked for the University we will also verify key information such as your dates of employment and reason for leaving your previous role with the department/unit where you worked.
