The role

This pivotal role requires a dynamic Senior Non-Functional Testing Specialist to lead and develop non-functional testing strategies, resources, and automation frameworks, while offering consultancy to the wider university. As the technical specialist, you will influence strategic planning discussions, formulate test plans, and support both project and operational initiatives. The successful candidate will lead initiatives for continuous improvement related to software quality assurance specifically related to test automation and non-functional testing.

The postholder will be responsible for managing multiple priorities and projects, delivering equally across their allocated initiatives. The ideal candidate can demonstrate experience of non-functional testing methods and test automation frameworks and managing continuous improvement initiatives. Additionally, the Testing Architect will work closely with Portfolio QA Managers and Project Managers ensuring seamless integration of non-functional testing and test automation efforts.



Responsibilities

Lead and develop non-functional testing strategies, resources, automation frameworks and offer consultancy to the wider university.

As the technical specialist influence strategic planning discussions, formulate test plans and influence business cases to secure investment with stakeholder support.

Contribute as the technical specialist to strategic service transition and operational initiatives.

Ensure robust decision-making and risk mitigation by providing expert guidance on software quality assurance and testing best practices to senior management, program leaders, and technical teams.

Lead initiatives for improving non-functional testing processes and automation, promote best practices, and be an advocate for these disciplines within the organisation.

Develop testing methodologies, write technical reports, and present findings at internal and external meetings.

Provide mentorship for junior testers, contribute to training sessions, and share knowledge through workshops and seminars.

Previous experience of leading and motivating a team in matrix management environment, including both business and technical staff.

Proven experience of identifying, presenting and implementing improvements that contribute to continuous service initiatives.
