This role offers a unique opportunity to receive on-the-job training and obtain relevant role specific accredited qualifications. You will be part of a dynamic and growing professional community, contributing to various projects that support the University's evolving digital needs.

During your 30-month role, you will:

- Develop professionally with training, mentorship, and real-world software development experience
- Work on meaningful projects that support cutting-edge research, teaching, and administration
- Collaborate with experts in a dynamic and supportive environment
- Be part of innovation in agile change delivery and digital transformation

Flexible working

You will be expected to be on-site for a minimum of two days per week, with additional days as necessary to assist with project requirements



Responsibilities

(This section tries to give you a feel of what your day-to-day activities at work will be. This is just the basics, there will be more as your training progresses)

1. Learn to review software requirements and specifications for software functionality to develop working software.
2. Develop skills to design and develop applications for non-complex projects.
3. With support, learn to design and build software application functionality with expected results.
4. Troubleshoot and support software applications that are in production.
5. Generate reports and monitor cloud hosting metrics as part of a DevOps team.
6. Document applications and functionality to an appropriate level.
7. Take responsibility for small enhancement projects.

Selection criteria

Essential selection criteria

When your application is assessed, these are the things that we will look for. Try to show in your application that you have these qualities, qualifications, or experience. Try to highlight your strengths in as many areas as you can by providing examples of what you have learned at university or through any previous work experience, or extracurricular activities.

Your application should demonstrate how you meet the following criteria:

1. Educated to degree level (2:1 or above) or equivalent qualification (including GCSE standard English and Maths grade 4 or above)
2. Experience of developing software in Microsoft technologies such as C#, JavaScript, Power Platform
3. Experience of cloud hosting in Azure is desirable
4. Logical and creative thinking skills
5. Can demonstrate attention to detail
6. Ability to work independently and to take responsibility
7. Comfortable working as part of a team
8. A thorough and organised approach
9. Able to communicate clearly
10. Able to demonstrate an aptitude for the skills taught in the Apprenticeship (for example through work experience, qualifications or references)
11. Experience of Microsoft Office applications, including Word and Excel
12. An interest in software and technology

Pre-employment screening

Standard checks

If you are offered the post, the offer will be subject to standard pre-employment checks. You will be asked to provide: proof of your right-to-work in the UK; proof of your identity; and (if we haven't done so already) we will contact the referees you have nominated. Your application will be judged solely on the basis of how you demonstrate that you meet the selection criteria stated in the job description.

As part of your application you will be asked to provide details of two referees and indicate whether we can contact them now.

The supporting statement must explain how you meet **each** of the selection criteria for the post using examples of your skills and experience. This may include experience gained in employment, education, or during career breaks (such as time out to care for dependants).

Please upload all documents **as PDF files** with your name and the document type in the filename. (Customise this statement to confirm the document(s) you would like the applicant to attach, but make sure that you keep the reference to PDF.

All applications must be received by **midday** UK time on the closing date stated in the online advertisement.

If you currently work for the University please note that:

- as part of the referencing process, we will contact your current department to confirm basic employment details including reason for leaving
- although employees may hold multiple part-time posts, they may not hold more than the equivalent of a full time post.
